Immigration to the United States showed a falling off during the last fiscal year of 141,034. This, however, was largely in consequence of restrictive legislation. Altogether 440,783 immigrants sought admission and of these 1,093 were debarred for special causes. Besides this, 577 were returned for having become charges upon the public within one year of arriving. Notwithstanding all the precautions, the republic seems still to attract undesirable material. As a further protection, it is now proposed to enact that courts shall have power to deport all aliens who, within two years from the time of landing, are convicted of any crime or misdemeanor which in the opinion of the court renders them undesirable citizens. This is intended as a blow at the anarchists.

"The Liquor License Act."

As the liquor traffic in Kent Co. is carried on under this Act it may be well that its provisions should be known. These may be briefly set forth under the three following divisions:—The people, the tavern-keeper and the inspector.

1. THE PEOPLE.—By this Act, licenses to traffic in intoxicating liquors are virtually in the hands of the people. We say virtually for though the municipal council may pass a resolution authorizing the inspector whom they may appoint to issue a license in favour of some particular individual, his application for such license "must be accompanied by a certificate of one-third of the rate-payers in a polling subdivision in which the premises sought to be licensed" are situated. It is also enacted that "no license shall be granted if the majority of the ratepayers in any city or incorporated town or parish petition against it."

The licenses to be granted must bear some relation to the number of inhabitants. In cities and incorporated towns one tavern license may be granted "for each full two hundred and fifty of the first one thousand of the population," "and one for each full five hundred over one thousand of population." In parishes such a license may be granted "for each four hundred up to twelve hundred of population, and one for each full thousand beyond twelve hundred of population." And in small parishes a single license may be granted notwithstanding the population of such a parish does not amount to four hundred.

Nor may all classes of people purchase at all times intoxicating liquors from licensed taverns. A minor or young person may not receive either for his own use or that of others any liquor from such a tavern; and people under this act have the right, through the inspector, of prohibiting the tavern keeper either personally or by others acting for him to sell or deliver any liquor to certain friends or others who have contracted the habit of drinking intoxicating liquors to excess. Nor may such liquors be purchased on Sabbath; at any time earlier than six o'clock in the morning or later than ten o'clock in the evening during the first five lawful days of the week; or at any time after seven o'clock on the evening of Saturday.

II. THE TAVERN KEEPER.—According to this act many persons who held licenses under the former state of things are not now qualified to do so. All persons bearing a bad character, given to intoxication, who have forfeited a license, or have been convicted of selling liquor without a license during the past three years, whose business premises are not of sufficient capacity, or are situated in the immediate vicinity of a place of worship, hospital or school may not have a license granted unto them.

Persons holding licenses must have these exhibited in some prominent place, produce and deliver the same to the magistrate when accused of any violation of their conditions, and if the accusation is proved the conviction is endorsed on the license, and should they be convicted for a third time the magistrate shall retain the same, and declare the holder or holders thereof disqualified under the act. No gambling is to be permitted on licensed premises; goods may not be received in exchange for liquor, those permitting drunkenness on their premises may be prosecuted, and in the event of death resulting from excessive drinking, the person in whose house the liquor was procured is liable to be sued for a sum of money not less than one hundred or more than one thousand dollars.

No tavern-keeper under this Act can be elected a member of the municipal council, appointed to hold a place in the commission of the peace, or serve as a trustee of schools; and any person holding one or other of these offices shall on making application for a tavern license under this Act forfeit such office and appointment.

III. THE INSPECTOR.—Another thing under the Act is the appointment of an Inspector who must in no way have any connection with the liquor traffic, and whose power is such as to enforce obedience to its requirements.

These are the leading provisions of this Act to which the attention of the readers of THE REVIEW is earnestly invited.

Neal Dow Says It's a Success.

TORONTO, Nov. 11.—In view of the statement made by Goldwin Smith to the effect that prohibition in Maine was a failure, Rev. Dr. Withrow wrote to General Neal Dow for his opinion on that point. General Dow replied at some length, positively asserting that prohibition in Maine is a great success and giving seven reasons for his belief.

Firstly, Gen. Dow points out that Maine was formerly the poorest State in the Union and that the people consumed much liquor. Now very little is consumed.

2. It is now one of the most prosperous States, J. G. Blaine having declared that it was the most prosperous of all.

3. There are no distilleries or breweries in the State.


4. There are no wholesale dealers, and what few retailers there are have to do business on the sly.

5. In three-quarters of the State a whole generation has never seen a rum-shop or the effects of liquor drinking.

6. In 1886 after an experience of 33 years an affirmative vote of 45,075 for prohibition was given, this being three times as large as the negative vote.

7. Every decent man has abandoned the liquor trade and what is done now is in the hands of the lowest classes, usually foreigners. That there are infractions it is true, but these are due to defects in the law, which will be remedied as soon as possible.

In closing General Dow expresses an earnest hope that Canada may throw off the yoke which the liquor trade now has on her.
