THE HOUSE OF LORDS. The rejection of the Home Rule Bill in the House of Lords has apparently raised an even more important issue in Great Britain, and the question of mending or ending the upper chamber is being seriously discussed by friends of the Irish Cause. The Radicals declare that the time has come to act in the matter, and the manifesto of the National Liberal Federation issued last week, has a business like ring. It declares that the action of the Lords in rejecting the measure, "not only marks another stage in the history of the Irish question, but has bearings so important to our system of Parliamentary Government as to call for very careful consideration." Though the name of Mr. Gladstone does not appear in connection with the circular, it is known that the leaders in the movement are the closest political friends of the premier, and the document was no doubt issued with his knowledge and approval. It further contains a quotation from Mr. Gladstone's Newcastle speech delivered two years ago, wherein he declared that "if Lord Salisbury's threats are carried out the House of Lords will raise up a question which will take preeedence of every other question because upon that question will depend whether, the country is or is not self-governing or whether, on the contrary, there is a power not upon nor behind the throne, but between the throne and the people, that will stop altogether the action of the constitutional machinery." "That issue is now raised." the document declares, " and the question of mending or ending the House of Lords, which held a subordinate place in the Newcastle programme, may before long, as Mr. Gladstone forecasted, displace for a while all other subjects of reform and cry aloud for vigorous and unflinching treatment. If the House of Lords is faithful to its traditions and practises, it will capitulate; if it is not, we of the Liberal party will enter on a fight, of the result of which we shall not be afraid." It must be remembered that the House of Lords is unlike any upper chamber in existence in Canada or the United States The members of the Canadian Senate for instance, are appointed for life. Their number is limited by the constitution and they are supposed to owe their appointment to some especial fitness for the position. The British House of Lords is comprised of hereditary and ecclesiastical


