**"An Obstinate Juryman."**  
 The London Daily News says: The most remarkable case of a jury "standing out" against what seemed irrefutable testimony, and as through the resolution of one man, occurred before Chief Justice Dyer. He presided at a murder trial in which everything went against the prisoner who on his part could only say that on his going to work in the morning he had found the murdered man dying, and tried to help him, whereby he had become covered with blood; but when the man presently died, he came away and said nothing about it, because he was known to have had a quarrel with the deceased, and feared he might get into trouble. The hay fork with which the man had been murdered had the prisoner's name on it. In other respects his guilt appeared to be established, and the Chief Justice was convinced of it but the jury returned a verdict of "Not guilty."

This was Chief Justice Dyer's case, and he put some very searching questions to the High Sheriff. The cause of the acquittal, said the official, was undoubtedly the foreman, a farmer of excellent character, esteemed by all his neighbors and very unlikely to be obstinate or vexatious. "Then," said the judge, "I must see this foreman, for an explanation of the matter I will have." The foreman came, and after extracting from his lordship a promise of security, proved at once that the prisoner had been rightfully acquitted. "For," said he, "it was myself who killed the man."

It had been no murder, for the other had attacked him with the hay fork, and (as he showed) severely injured him, but in the struggle to get possession of the weapon he had the misfortune to give the man a fatal wound. He had no fears as to his being found guilty, but, the assizes being just over, his farm and affairs would have been ruined by a confession, through lying in jail so long, so he suffered matters to take their course.

He was horrified to find one of his own servants accused of the murder; he supported his wife and children while in jail; managed to be placed on the jury and elected foreman. He added that if he had failed in this he would certainly have confessed to his own share in the business, and the judge believed him.

Every year for fifteen years his lordship made enquiries as to the foreman's existence, and at last happening to survive him he considered himself free to tell the story.

**The International Railroad.**

There are many international or practically international railroads. There is, however, a plan for an international railroad; that is, one that shall run from North America into South America, and surveys therefor are now under way. A general plan for the road was adopted by the International American Conference, which was in session at Washington at various times from October 2, 1889, to April 19, 1890. The general route of the road is down through Mexico, Central America, and along the passes to the Andes as far south as Valparaiso, in Chili, making connections with various existing or proposed roads. The United States has had three expeditions surveying routes in South America, and some of the South American States have also moved in the matter, but we have done most of the work as yet. No company has been formed to manage the line when built, nor has any amount been suggested as necessary to carry out such a road. The amount would be enormous.

**Weighing a Live Trout.**

A few days ago a party of anglers visited the hatching works of the State Fish Commission at Cold Spring Harbor, Long Island, says the N. Y. Sun, and were estimating the weight of the larger trout which was swimming at their feet. One very large specimen attracted their attention, and a veteran angler said: "That fellow will weigh six pounds."

"Bet you a cigar that it won't go over four," said another.

"I'll split the difference with each of you and take both figures that the fish will weigh over four and under six pounds," said a third.

Just then the superintendent, Mr. Fred Mather, came out of the building, and they at once appealed to him in chorus: "Major, how much will that fish weigh?"

"About eight pounds," was the reply. "But I see you look incredulous. We'll find its weight precisely." "Peter," said the superintendent to one of his men "get all hands, the deep seine, a washtub, and the scales. Get out the big trout and weigh it."

Within ten minutes the net brought up a mass of great trout which were allowed to escape, all except the big one. The washtub, two feet in diameter, was sunk under it, then lifted, and the party saw with it a magnificent brown trout that could not extend its tail within the limits of its confinement, whose breadth and depth were surprising. The angler who had bet six pounds wanted to make it twelve, and the four-pound man became interested in the flock of wood ducks and teal near by, which are one of the sights of the place. "A fish in the water," said Major Mather, "never looks as large as when out of it. The depth is greatly foreshortened, and even the length and breadth do not seem to show their full extent. Boys, weigh the tub."

A pole over the shoulders of two men held the scales, and when they straightened up and the tub with its contents cleared the ground the scale indicated ninety-two pounds. The fish was then carefully lifted out and sent swimming away, and the tub and water pulled the scales at eighty-three pounds, leaving nine pounds as the weight of the trout.

"That fish," said the Major, "is the common brook trout of Europe. I imported the first eggs after taking the fish with the fly in the 'Black Forest' in Germany, and it is destined to be a favorite when better known."

**Saved From an Awful Death.**

A party of cattlemen out on the Mojave Desert recently came across the trail of two men and two burros. The two men were miners, who had lost their way a week before. Both men recovered after a few days of care at the ranch.


