### Restigouche.

A fine smart child, 2 years old, son of Mr. D. Nicol, New Mills, on the 16th inst., fell into a tub of hot water, and died from the effect the following day.

On the 17th inst. the large dwelling house, capacious barns and other buildings belonging to Mr. Alex. Dickie, Sea Side, Rest, were consumed by fire. 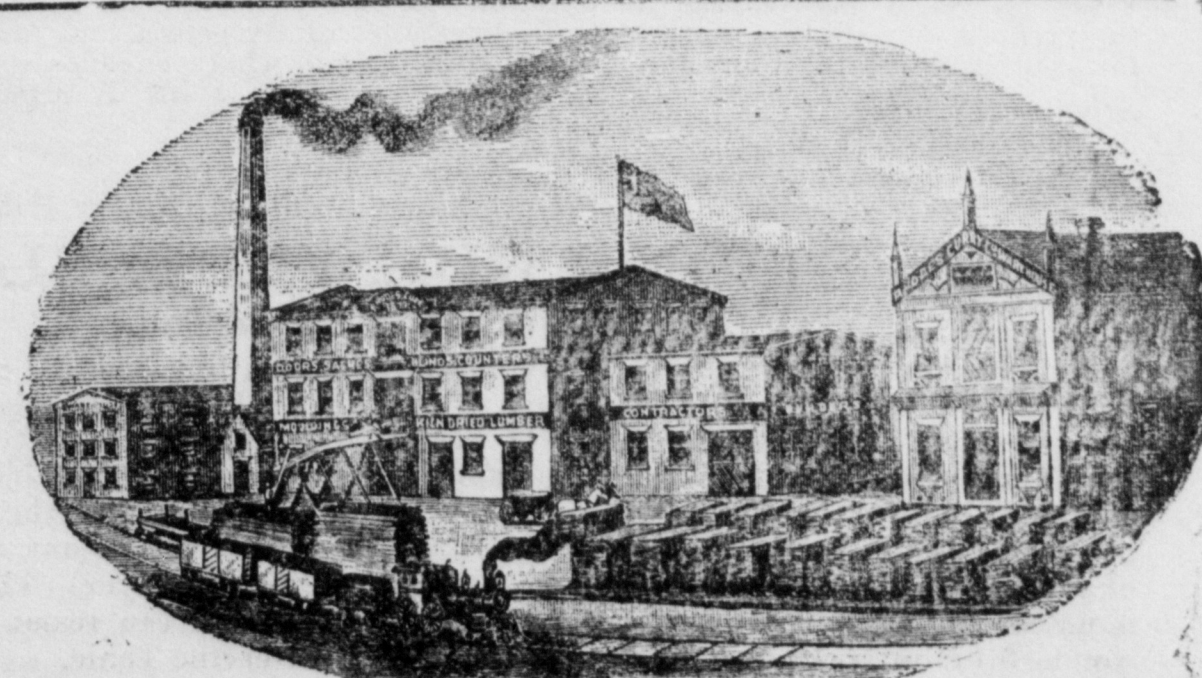
