BURNED TO DEATH. - A very sad accident attended with fatal results, occurred at Edmunston, N. B., on Monday night last. The 12 year old daughter of Mr. Thos. Chasse went upstairs to prepare for bed on the evening referred to. She carried in her hand a medium sized lamp, which exploded the moment she entered the bedroom. Her clothing being saturated with oil she was immediately enshrouded in flames, and her father who heard her screams rushed to her assistance and disrobed her but not before she had been almost burned to death and his hands and arms so badly scorched that the skin all blistered and the nails dropped from his fingers. She died shortly after.

EQUITY COURT .- James D. Irving vs. Thomas McWilliams was taken up Tuesday afternoon. This is a dispute as to timber license between the parties, who are millowners in Kent county. Mr. Teed and the Attorney General for the plaintiff and J. D. Phinney, Q. C., and A. A. Stockton, Q. C., for the defendant. The plaintiff alleges that he and the defendant went to Fredericton to attend a sale of the right to cut lumber, etc., on the crown lands in dispute in 1893; that both desired these particular lots; that they entered into an agreement whereby the defendant was to purchase the right to cut in his own name, take out the license, and that the said lands should be divided between them, each paying a share of the license fee, but that the defendant refused to carry out this agreement. The defendant disputes this agreement. He admits that a certain agreement was made, but the agreement as he puts it is different from the plaintiff's .- Globe.

BRITISH LUMBER MARKET. -- The London Timber Trades Journal of Sept. 7th says that at the Surrey Commercial Docks spruce presents a favorable position, the present stock of deals being less than it was a month ago by 34,641 pieces. Ends, however, have increased by 132,072. With regard, however, to the diminution of deals there is, it adds, a large overside delivery of spruce, consequently the dock figures do not index truly the state of the supply of whitewood. At Cardiff trade was quiet, recent arrivals noted being the Arracan from St. John and Joseph Rane, 8 from Miramichi. The Liverpool situation is thus summed up: "The slight improvement in business we have recently experienced in our trade here, and which has been noted in our columns from time to time, still continues. We are gratified to find that this note is reechoed in some of the Liverpool brokers' circulars The monthly statistics show with a few exceptions what a steady demand has existed during the present season. The import has, however, been more than sufficient for the wants of the market, and stocks generally are ample,"

Canadian Cheese.


