DEATH OF DR. PALLEN.-After a lengthy illness Dr. John Pallen, one of the oldest and most respected physicians of the county, died at his residence in Chatham on the night of Wednesday last. He was born in London, G. B., in 1815 and came to this country with his father when he was very young. He was here at the time of the great Miramichi fire, being then about fourteen years of age. He studied medicine with the late Dr. Key and after he had passed his examination he went to London. After walking the wards of St. Bartholomew's Hospital and attending lectures delivered by the ablest medical practitioners in that institution he returned to this country and took up his residence in Bathurst. After he had practised there for two or three years he left and came to Chatham. After several years practise here he left for Richibucto, but after he had been there but a short time he once more returned to Chatham, where for the last forty years he has practised his profession. Throughout the length and breadth of this county the Doctor was well and favorably known and his many warm friends among the oldest residents will be grieved to hear of his death .- World.
