**THE FATHER OF THE CANADIAN SENATE.**

The Hon. David Wark, who for several years represented Kent County in the Provincial Legislature, is at present and has been for some time the oldest member of the Dominion Senate, and although now in his ninety first year still enjoys good health and takes an active interest in the legislation of that important branch as well as in public affairs generally. Mr. Wark, who is descended from Scotch ancestors who settled in Ulster in the 17th century, was born near Londonderry, Ireland, on the 19th of February, 1804, and came to New Brunswick in his twenty-first year, landing at St. John, and shortly afterwards removing to Richibucto. He had the benefit of a good common school education received under the Irish school system, and shortly after his arrival in Richibucto commenced teaching school, in which occupation he continued for some time. He afterwards entered into mercantile life and for several years until his removal from Richibucto to Fredericton, where he now resides, carried on quite an extensive business in the building erected by him and now occupied by THE REVIEW.

Mr. Wark also owned and worked a large and valuable farm at Kingston, Kent County, and by his enterprise and readiness to adopt advanced agricultural methods, did much to encourage a better system of farming in Richibucto and the adjoining parishes. Mr. Wark was first elected to represent Kent County in the House of Assembly in December, 1842 (nearly two years before Sir John A. McDonald entered political life) and sat as the representative of this County until 1851, when he was appointed to the Legislative Council, where he remained until the Union of the Provinces in 1867, when he was called to the Senate by royal proclamation. He was a member of the Provincial Government from 1855 to 1862, and for a few months in 1867 held the office of Receiver General. He has been for some years a member of the Senate of the University of New Brunswick. It will be seen that Senator Wark has been in public life continuously for over 52 years. The nearest in age to Mr. Wark in the Canadian Senate are Senator Lewin and Dickey, who were both born in 1812.

In the British House of Lords there is only one member who is older than Senator Wark, namely, Dr. Richard Durnford, bishop of Chichester, who was born in 1802. The eldest temporal lord in that House is the Earl of Mansfield born in 1806. While in Canada we have only three Senators, (Wark, Lewin and Dickey) who are upwards of 82 years of age, the British House of Lords has twelve members in that category, one of whom is in his 93rd year.

**ELECTED BY ACCLAMATION.**

The election of Dr. Atkinson by acclamation to the vacant seat in Carleton County, came as a surprise to those who did not know the true state of affairs in that constituency. The opinion was general that Dr. Atkinson would easily defeat any candidate put up against him, but the public were taken entirely by surprise when it was announced that the government had abandoned the field and allowed an election by acclamation. Dr. Atkinson is an uncompromising opponent of the government and at the last general election Mr. Blair went to great lengths to secure his defeat. Not only was Hon. H. A. Connell, one of his opponents, given a seat in the Executive, but at least \$75,000 of the provincial funds were squandered on the Woodstock Bridge, about which so much has been said and heard. The doctor was, however, a hard man to beat and when the election was over it was found that notwithstanding all the efforts of the government, he was elected by a majority of about twenty over Mr. Diblee. Then it was that the Sheriff of Carleton clothed with the advice of Mr. W. W. Weldon, (who had apparently forgotten his denunciations of the Queens County steal) proceeded to count Dr. Atkinson out and count Mr. Diblee in. The steal was accomplished to the satisfaction of the attorney general but "The

best laid schemes of mice and men gang aft a-gley," Mr. Connell in less than a year became dissatisfied with Mr. Blair and his methods and resigned his seat. This took place at the beginning of last year, and since that time the attorney general has been striving to induce a candidate to take the field in opposition to Dr. Atkinson. Several of the leading men of the County were approached, but those who were not supporting the doctor could not be induced to face certain defeat. After a year's delay, the election was called on and notwithstanding the \$75,000 expenditure, the bestowal of a portfolio and all the methods resorted to to keep Dr. Atkinson at home, no one could be found to oppose him. It is certainly an "extraordinary incident" that a constituency carried by the government at a general election two years ago, should now at a bye-election be allowed to go by default.

A rumor is going the rounds of the press that Hon. A. G. Blair will be appointed to the Supreme Court bench. Another report is to the effect that the Attorney General is seeking the Conservative nomination for Queens and Sunbury. Still another report gives him the Liberal nomination for Westmorland. We take the liberty of refusing to believe any of these rumors. There does not appear to be any good reason shown why he should be appointed to the Supreme bench over the heads of other applicants equally well qualified and with more claims on the party. For the same reason it is doubtful if he could succeed in securing the Conservative nomination for Queens, and we doubt if Mr. Blair would care to face certain defeat in Westmorland as an opponent of Mr. Wood.

The Manitoba Legislature will meet on February sixth.

There are eleven vacant seats in the Canadian Senate.

The Nova Scotia local legislature meets on the 31st of January, the same day as that of the local legislature of New Brunswick.

Four judges of the supreme court of Canada have decided (two others dissenting) that the provincial legislatures have no power to prohibit either the importation or sale of intoxicating liquors in any quantity.

Sir Mackenzie Bowell is a Methodist; Sir John Thompson was a Roman Catholic; Sir John Abbott was an Episcopalian; Sir John McDonald was a Presbyterian and Hon. Alex. McKenzie was a Baptist.

In the United States, according to the Springfield Republican, "some 9,800 murders, 190 lynchings, and only 132 legal executions is the ugly story which the past year tells of the prevalence of crime and the faulty administration of justice." This means that one out of every fifty-one murderers is illegally executed, and one out of every seventy-four is put to death according to a legal sentence. "It moreover frequently happens that the lynchers execute the wrong man. In these figures there is much food for reflection, and the conclusions are anything but creditable to the great Republic.—Ex.

**County Court of Kent.**

The case of Hugh M. Ferguson vs. John Reid, executor of Joseph Reid, deceased, was concluded Tuesday afternoon. This was an action against defendant as executor de son tort for a suit of clothes made and delivered to the late Joseph Reid. His Honor Judge Wedderburn took the ground that the action should have been brought for goods sold and delivered, whereas the plaintiff sued for work and labor. He accordingly charged the jury that there was no evidence of work and labor submitted and directed them to find a verdict for defendant. C. Richardson for plaintiff. H. H. James for defendant.

In the case of George K. McLeod vs. Beloney Miller, the jury assessed damages at \$42.95. Wm. D. Carter for plaintiff.

In the case of George K. McLeod vs. Robert Graham, damages were assessed at \$218.51. Wm. D. Carter for plaintiff.

The case of John W. Harnett vs. James A. Jardine was an action brought against defendant as executor of the late Alexander Roxborough, deceased, for \$28.00 owed by deceased to plaintiff. The defence was that the estate was fully administered. On the trial it was shown that a certain amount of the property of deceased came into the hands of defendant. Defendant contended, however, that this amount had been paid out in funeral expenses. The judge left to the jury to say whether these charges for funeral expenses were reasonable and made bona fide. The jury found a verdict for plaintiff for \$25.00. Phinney & Carter for plaintiff. C. Richardson for defendant. Court adjourned sine die on Thursday.

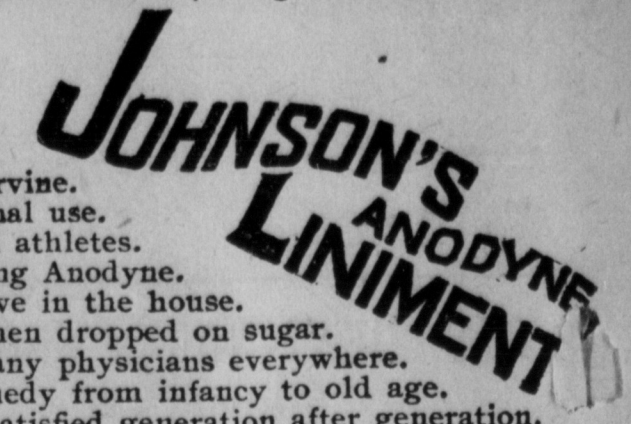
