

As a public speaker he stands in the front rank. As the representative of our mixed population he has the great advantage of speak ing both the English and French languages with fluency and precision. This is no only an advantage so far as his intercourse with the electors and learning their wants and requirements are concerned, but it is an undoubted advantage also, to a mem. ber of a parliament in which both lan guages are spoken. His knowledge of public questions is extensive and indisputably he has attended carefully to his public duties and holds a good position among the men who sit in the national parliament. He has been in the past a moderate man rather than an extreme partisan, and is admittedly free from sectarian bigotry. These qualifications will no doubt bear due weight with the elec tors in making their choice of a representative in the new parliament.

#### THE POLITICAL OUTLOOK IN KENT.

It has always been customary—and we suppose it always will be customary-for political parties to exaggerate the prospects of their favourite candidates before elections. There are some people so wise -in their own estimation-as to be able to foreshadow political events. Their predictions must, of course, be taken for what they are worth. There is no way of either contradicting or verifying their statements till the ballots have been counted; and if those who shall be doomed to disappointment on the 23rd of June derive any enjoyment from the hope that their respective candidate or party will win, it were a pity to dispel the delusion.

Hertofore in this County a Frenchspeaking candidate possessed, on account of his nationality, a decided advantage over an opponent of the English tongue, provided, of course, that other things were about equal. The Acadians of this County are a wideawake, intelligent people, and it is not at all probable that a man of Mr. LeBlanc's ability will receive a majority over a man of Mr. McInerney's well known standing and abilities. Mr. LeBlanc, is a straw blown about by every political wind. At one time or place he is a Liberal, at another he is an independent and it is quite probable that he could be a Conservative if his chances of success looked brighter in that political creed. We have nothing to say personally of Mr LeBlanc, and if the majority of the electors think fit to honor him with the position of Kent's representative, we can have no objection.

Mr. McInerney is a man of high edu cation who has made politics a life study He is a fluent 'speaker-an orator, some would say-capable of taking part in any discussion, or filling any place, even in the calinet. He is in the prime of manhood, and being a Roman Catholic, himself, his interest in religious matters are identical with those of the French people who are all Roman Catholics. Why then should the intelligent electors of Kent support Mr. LeBlanc over Mr. McInerney So far as can be judged at present Mr Geo. V. McInerney will be our next representative.


