Besides this there is going on a very heavy fall make, as every farmer has an abundance of feed, even though the pastures have failed in many localities during the last few weeks for want of rain It is estimated that the gross value of Canadian cheese exported this year will reach \$12,600,000. In butter the shipments have been unusually heavy. From Montreal the exports for one week during September reached 30,897 packages, being 17,147 packages more than during the previous week and 23,083 packages more than in the corresponding week of the previous year. The advance in price, too, must be considered here. The season opened at 14 cents, and now stands about 20 cents per pound, which has been equally good for dairymen and dealers


CIRCUIT COURT -The case of the Queen vs. Leger for rape was tried Wednesday, Mr. Savre prosecuting. The parties live in the Parish of St. Paul, where the al leged offence took place. As prisoner was too poor to employ anyone to defend him, His Honor requested Mr. Phinney, Q. C., to undertake the defence. The accused was acquitted on the count for rape, but of the indictment of an attempt to commit rape. His Honor in sentencing him to two years in the penitentiary at Dorchester, stated that he had first made up jail and found it in such a condition that he considered it would endanger the life of any one to be left there for even a short period and therefore felt that in justice to The total shipments of cheese the accused it would be necessary to send the duty of the Municipality to look after the juil and put it in a condition to receive prisoners without endangering their lives.

It is really humiliating that men, who otherwise stand well in the community for their probity and honesty, will in these cases sink their manhood by entirely disregard. ing the truth. These men seem to think in the case of liquor dealers it is proper and right to screen those who openly violate the law every day by selling without license, selling after hours, selling to minors, to drunkards and on Sundays. Does this liquor license law of ours regulate the sale of intoxicants? We say it does not. On the contrary, we have men in our midst who boldly and openly violate the law in every respect, and some in the town who openly sell without license and defy the law. One man who thus openly violates the law, openly tampers with the witnesses when a complaint is brought against him for selling without a license. How long is this to continue, and the lawabiding citizens of the county look on and by their silence allow this state of things to continue? We think it is an everlasting disgrace, and if not soon checked will before long destroy all law and order in church at Bass River for a few sabbaths, abiding citizens to put forth their most church last evening. strenuous efforts to enforce the law against those law-breakers and to shew them that we, as a people, will not allow them to openly violate every principle of decency and order. We understand that summonses in these cases were issued for the witnesses, in some cases twice, but were flagrantly disregarded. Warrants had to be issued for each one and then some of them took to the woods and escaped from the hands of the officers. 
