QUEBEC, March 28.—As soon as the new steamship for the winter ferry across the Straits of Northumberland arrives from Europe, the Stanley will be brought to Quebec and placed at the disposal of the Intercolonial Railway authorities, to be used in winter in keeping open communication between Quebec and the Intercolonial Railway at Levis.
