DEATH OF MR. THOS. T. GESSNER.—Mr. Thos. Gessner, an old and respected resident of Little River and Buctouche, died at his home on Saturday, April 22nd, at the advanced age of 76 years. He had been in failing health for some time, but was able to be about until a short time before his death. He leaves a widow, three daughters and a son the latter residing in Oregon, Empire City, to mourn the loss of a kind and affectionate husband and father. The services at the house and grave were conducted by Rev. C. H. Manaton. The pall bearers were Messrs. Leonard, Wood, James Bismarck, Alexander, Willie and John L. McKee.

LICENSE LAW IN BATHURST.—The trials of the violations of the Liquor License Act said to be committed by John P. Legere for selling during prohibited hours; Patrick P. Foley for a like offence, and two against P. Wilbur for having permitted gambling in his hotel, were brought before J. E. O'Brien, J. P., on Tuesday. Owing to the absence of several witnesses the cases have been adjourned until the 23rd day of May.—Bathurst Courier.

NEW TRIAL REFUSED.—In the case of Budd vs. Sherwood, an action of trespass to land in Buctouche tried at the Kent Circuit Court in September last in which a verdict was rendered for the plaintiff of \$100, and in which a motion for a new trial was made before the full court in Fredericton, the court last week delivered judgment refusing a new trial and sustaining the verdict. THE SIDEWALKS.—A stroll around our town calls attention to the need of numerous repairs and desirable extensions of the sidewalks, as well as requisite improvements on the streets. This is the season of the year when these matters should be attended to, and we feel assured that the subject requires only to be mentioned to induce the proper officers as well as the citizens generally to give them prompt attention. In many places planks are broken from the sidewalks and in others they are so decayed as to render them positively dangerous to pedestrians, especially after dark; while garbage, ashes and refuse have been allowed to accumulate in the gutters and on the streets. Road Commissioner Irving is generally regarded as a first rate official. He has made several improvements, especially in the street crossings and the walk from School street to St. Mary's Church, and is always ready to give the work his personal attention, but the means at his disposal are limited, and just now might well be supplemented by contributions from public-spirited citizens, as well as funds raised by some public entertainment to which all could contribute more or less. What is to prevent the Richibucto Brass Band, under the leadership of Prof. Johnson, assisted by our numerous good vocalists and proficient musicians, giving a public entertainment in the course of a few days? It is many months since Prof. Johnson and his associates have been heard in public, and they should now be greeted with a large audience, especially if the proceeds are to be devoted to needed public improvements. In the meantime let the needed repairs and cleaning of the streets be begun. The funds required can no doubt be raised to supplement the taxes collected by Commissioner Irving. What we purposed calling attention more particularly to, however, when we began to write this paragraph was the disgraceful condition of the sidewalk from Conductor Murray's to the Protestant cemetery. It is a long time since this walk was laid, under the direction we believe of Councillor Livingston, and it is now so broken and decayed as to be utterly useless. No promenade in the town is more frequented especially on Sundays and by those whose friends and relatives are buried in the cemetery, than this. An effort should at once be made to place a new sidewalk there. If the men will not look after it, why cannot the ladies of the town, following the example of their Kingston sisters, take the work in hand and accomplish it? Something should be done and at once. The present condition of the walk is a reproach to the town.

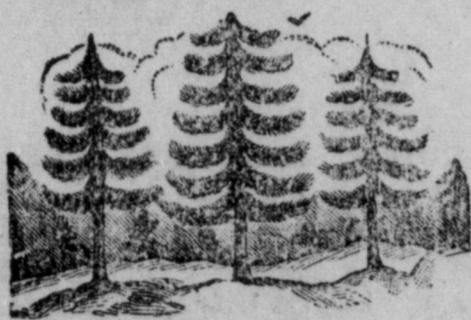

DEATH OF JESSIE SMITH.—The death of Miss Jessie Smith, of Buctouche, which occurred on Wednesday, the 3rd of May, has cast over the hearts of her relatives and many friends a gloom that will not lightly be shaken off. She was a girl of gay and sprightly temperament, full of mirth and harmless fun. Though a resident of this place but for a few months, she had won her way to the hearts of young and old, gay and grave. The evidence of the friends who nursed her during her painful illness, shows that her last days of consciousness were devoted to making sure her peace with God. Her illness, extending over a period of nearly one year, was very trying, and her last hours were passed in unconsciousness, which happily left her encased in a frame free from the torture of death. Many tender tokens of love were sent by her friends. A beautiful wreath of wild mayflowers, the gift of a dear young friend, encircled her head. A handsome wreath of ferns and white flowers was given by her sister, Mrs. Chas Lockhart, of Notre Dame, while lilies and other flowers were scattered over the fair, young dead. The funeral service held at her home was very impressive. Rev. Mr. Manaton and Rev. R. Barry Smith officiated; Rev. Mr. Vauz was also present. The hymns sung were, "Jesus lover of my soul," "Safe in the arms of Jesus," and her favorite, "Vale of Beulah." The funeral procession to the station was headed by the mission band, composed of about forty boys and girls wearing white bows. Next followed the pall-bearers, Allister Murray, Gordon Potts, Dr. Turgeon, Richard Sutton, Neil Ross and Thomas Gamble, bearing the casket. By their side, dressed in white with black sashes, walked four young girls, Edith James, Janie Keswick, Gertrude Hanagan and Irene Wry; a long train of mourners brought up the rear. From the station at Shediac, the funeral proceeded to the Episcopal church, where a number of friends and relatives were assembled. Rev. Mr. Bert gave a very consoling address and the precious dead was laid to rest in a sunny corner of the churchyard. Miss Jessie was 15 years and 10 months old. Her father and two brothers are away in the gold fields of Alaska and know nothing of the sad occurrence. Mrs. Smith and relatives desire to express their thanks to all the friends who so kindly assisted them in their trouble.
