ROBBERS' TORTURE.

KNOCKED SENSELESS BY MASKED MEN WHO WERE FOILED IN ATTEMPT TO GET \$400.

WILKESBARRE, Pa., June 23 .- Four desperadoes, who committed one of the most dastardly assaults in the history of this county, have been corralled, it is believed, in a house fifteen miles from here. An armed posse of farmers has surrounded the place and is keeping a sharp watch to see that the men do not escape. The farmers are afraid to take the house by storm as the men, who are all heavily armed, have already shown they do not hesitate to shoot or kill.

Mrs. Moore was beaten and kicked until she was unconscious, and her husband, after being tortured, was knocked senseless. The torture consisted in rubbing the muzzle of a revolver along his forehead until the flesh was raw. Then, in exasperation, one of the robbers knocked him senseless.

The robbers thought they had to deal with only the old couple, but they did not know that sleeping upstairs was ten year old Mabel Tubbs. She was awakened by the noises and heard the cries of the

Instead of screaming she kept quiet as a mouse, climbed out of her window and managed to swing herself to the ground by the limb of a tree. Then, with only her nightdress on and in bare feet, she ran to the nearest neighbor, James Harman, about half a mile away, and aroused him.

With William Franklin, Harman started off for the Moores' home, and near there met the four men on the road. Harman and Franklin, who were armed with rifles, called on the robbers to throw up their hands. The only reply was four shots, one ball grazing Harman's head A fusilade of shots then followed, each side taking shelter behind trees, and when Harman and Franklin exhausted their ammunition they went on to the Moore

Moore and his wife who were unconscious were revived and soon afterwards a party of men started on the trail of the robbers. They found that one had been badly wounded, for the others had carried him, and the ground was speckled with blood. This trail they followed three miles to the home of a notorious character, and there they have since been watch-

The Moores are in a precarious condition, the shock owing to their advanced age, having been very severe.

TABLE MANNERS.

At a dinner to which guests are bidden the gentlemen help to seat the ladies before taking their own places. If a clergyman is present it is customary to request him to ask blessing.

One should sit so as to bring the body about a foot from the table, and say a few words at the earliest opportunity to both neighbors wnether one has been presented or not. "The roof is an intro-

The napkin should be folded to half its amplitude and laid upon the lap, and the ladies remove their gloves. > Entrees are eaten with the fork alone. The roast imposes no special etiquette. If a vegetable is served as a separate course according to French fashion, each has its own punctilio.

> Asparagus may be held in the fingers if the stalks are not too slender and pliant or divided and eaten with a fork. In England one who would eat peas with a spoon would be regarded as a barbarian. Artichokes may also be eaten with the fingers, plucking the leaves to be eaten at the base of each.

The game follows with the salad, which last, if composed of lettuce, should be dipped in a sauce and the tiny morsel eaten with a fork alone, which may fold the leaves to a convenient size.

Ice cream is eaten with fork or spoon,

as one prefers, never with both. Fruit must never be bitten, but cut in small pieces and eaten in either the hand or with a fork.

One dips only the ends of the fingers in the finger bowl, after which, at a signal from the hostess, the ladies arise, placing the napkins, still unfolded at the side of their plates, as implying that they, of course, will not be used again, and withdraw from the room. The men rise and remain standing, while the one nearest the door holds it open for the ladies to pass through.
