THE POLITICAL CAMPAIGN.

AND ENTHUSIASTIC MEETINGS HELD AT WEST BRANCH, BASS RIVER, HARCOURT AND SOUTH BRANCH.

WEST BRANCH, Oct. 18 .- The meeting held in the Public Hall last night in the interest of Hon. O. J. LeBlanc, was the largest and most successful ever held in this district. Mr. Alex. Mundle, Esq., was elected chairman and made a few remarks before introducing the speakers. The first speaker was Mr. H. H. James, of Buctouche, who spoke for some time dealing with the political issues of the day and was interrupted at different times by applause. Hon. O. J. LeBlanc was the next speaker, and was loudly applauded on arising. > GOTRO DISCHARGED.-Judge Wilson heard a habeas corpus application Friday afternoon at Fredericton for the discharge from custody of George Gotreau, of Acadiaville, Kent county, who has been confined ln Kent county jail since Sept. 11 under warrant of commitment issued upon a conviction made before R. H. Davis, stipendiary magistrate of Richibucto, for violation of the Liquor License Act. 
