CONSTANTINOPLE, March 8 .- The statement is confirmed that the government, with a view to meeting extraordinary expenses in the army, is considering a proposal made for a loan of three million Turkish pounds, to be guaranteed by the proceeds of six per cent. surtax on taxes of the empire, and two per cent. surtax on inland cuttoms duties. The loan will be issued at eighty with interest at four per cent. and one per cent sinking fund. The members of the German syndicate which offered the Porte a loan, assert that other capitalists are invited to participate, and consequently it is incorrect to say the loan is conditional upon the Germans getting further orders for arms and ammunition.

down from the woods this week on their way home in Chipman, having finished their winter operations.




