COUNTY COURT.

The January Term of the Kent County Court opened here on Tuesday of last week and closed Saturday night. There were two criminal cases entered, namely, the Queen vs. A. P. Kinread for forgery, and the Queen vs. Mary Barrieau for larceny. A true bill was found against Kinread and no bill in the latter case. Kinread was tried on Friday before a jury and acquitted. C. Richardson, Deputy Clerk of the Court, conducted the prosecution and J. D. Phinney, Q. C., the defence.

The following was the civil docket: Thomas J. Bourque vs. James Fitzgerald-Wm. D. Carter for the plaintiff;

J. D. Phinney for defendant. Wm. Agnew vs. John Ryan-C. Richardson for the plaintiff; W. D. Carter for the defendant.

George Warman vs. James Chrystal-Wm. D. Carter for plaintiff, W. B. Chandler for defendant.

James Bigley vs. Leon Arsenault-Wm. D. Carter for plaintiff, J. D. Phinney for

defendant. Edward Hannah vs. Edward Cormier-Wm. D. Carter for plaintiff, E. Girouard for defendant.

The case of Bourque vs Fitzgerald was an action brought to recover a doctor's bill. The defence was mal practice by the plaintiff in the operation for which the bill was incurred. The case lasted three days and the expert testimony of Doctors McDonald and Benson of Chatham, and LeBel, of Buctouche, was given. Verdict for plaintiff for \$75.00. George V. McInerney and Wm. D. Carter for plaintiff. J. D. Phinney for defendant.

Agnew vs. Ryan was an action of libel slander and resulted in a verdict for defendant. Caleb Richardson for plaintiff and W D. Carter for defendant.

Warman vs. Chrystal was an action for malicious prosecution. In July last the defendant laid a charge of theft against plaintiff before Stipendiary Bailey at Harcourt in which a conviction was made. This conviction was afterwards set aside by C. J. Tuck and the present action was then brought. Verdict for plaintiff for \$1.00. Wm. D. Carter and Geo. V. Mc-Inerney for plaintiff, J. D. Phinney for defendant.

Bigley vs. Arsineau was stood over till July, and Hannay vs. Cormier settled Court then adjourned sine die.


LETTER OF CONDOLENCE

STORY OF HER MAJESTY'S LAST DAY.

London, Jan. 22.-A special despatch from Cowes last evening says Emperor William was admitted to the Queen's presence at about 5 o'clock. She spoke a few words to him and after two or three minutes he withdrew. The Queen took a little nourishment and fell asleep in the arms of the Princess of Wales.

The correspondent of the Associated Press is informed that the members of the royal family were called to a room adjoining the Queen's bedchamber no less than four times yesterday morning and were kept in momentary expectation of being summoned to witness the end up to half past five. Her Majesty's physicians then had only a vestige of hope that they would be able to keep the Queen's feeble life in existence until the Prince of Wales arrived.

To secure this result they resorted to the frequent use of brandy and champagne. These stimulants used to an extent which only the greatest emergency justified, worked their process, and when the Prince of Wales and Emperor William entered the castle grounds at 11.30 a. m. they found the Queen a

trifle better than had been expected. The desperate remedies employed Monday morning to enable Her Majesty to live until her eldest sons arrived will not St. Andrew's Presbyterian Church be used again to the same extent, for the doctors are fearful that the remedy might be worse than the disease. They trust to prolong her life by a moderate application of stimulants, combined with as much nourishment as can be assimilated. Such expedients as were employed during Sunday evening and Monday morning are not

considered justifiable. HER PHYSICIANS WONDERED.

The Queen's rally astonished no one more than her physicians and when, at 4 o'clock yesterday afternoon, they heard her ask for chicken broth their amazement almost equalled their delight. Privately, however, they built no false hope upon these fading signs of what has been one of the strongest constitutions with which a woman was ever endowed.

Despite the favorable afternoon the doctors dreaded greatly the period between six o'clock and midnight. When that was safely passed they seemed hopeful of Her majesty living at least through another day, although the memory of the previous night's relapse kept their anxiety at high tension.


