NOTES FROM THE CLYDE.

Never Disappoints

The seeing in of the New Year is function which the ordinary Scotsman never neglects. In Glasgow during the last hours of the dying year the crowds on the streets are seen to be steadily moving in one direction, viz., towards the Cross. En masse the crowds may be said to be steadily moving in that direction, but a large percentage of the individual members may be seen to be somewhat erratic in their movements. A special providence seems to guard the footsteps of those who have "a wee drappie o' it." As the hands of the Town clock near the witching hour of midnight a deep bush falls upon the assembled thousands. The drunkest and noisiest of them suddenly become sobered and quiet and even the favourite shout of the Glasgow "Keelie" "How wull!" is quieted. As soon as the deep toned notes of the bell finish the 12 strokes the tension is relaxed and the new year is welcomed in by the shouts of thousands and the hoarse wail of all the steam sirens on the different works of the city. Bottles of whiskey are at once produced and handed round until they are emptied. Too often dead sodjers are flying into the crowd and many an inoffensive citizen has had his head broken. The favourite place for smashing the empty bottles is the pedestal of the equestrian statute of King William. If the bronze effigy could speak what a tale he could unfold. Above the clamour of the crowds the bells in the steeple are ringing in the New Year. "Auld lang syne" chimes out loud and clear and the crowd begins to break up to go on first footing expeditions, at least those who are able to travel. Some of them sink down on the pavement and if their friends cannot get them away the policemen on the beat have to trundle them off to the cells. The firstfooters go and call on their friends. Each must have something in his hand or he won't be allowed in. A first-footer with out a small gift would be sure to bring bad luck. Years ago I remember my landlady had her door locked so that we could not get in until she was sure we had brought her something. Fortunately l knew the custom and had duly provided

against this contingency. The scenes at the Cross this year have been much the same as usual. The crowd was perhaps larger than ever before as the birth of a new century cannot be witnessed more than once by the same person as rule. Thirty thousand people were said to have gathered there to hail the new year. The weather was mild but damp. We have had the most extraordinary run of wet weather for months that one begins to wonder what a fine, dry day is like. I doubt if there have been many wetter years during the 19th century than the

last one was. Last week we were visited with a hurricane which rivaled the disastrous Tay Bridge gale. A good deal of damage was done and several lives lost in the city. The exhibition buildings escaped wonder fully. Some of the pavilion in proces of erection were pretty badly damaged, but the main ones escaped with only trifling injury. It blew so hard that one would not have been surprised if the great dome had gone.

During the New Year week the works are all closed. The streets are very crowded and there is a good deal of drunk enness. This is apparently unseparable from holidays among the working-classes in Scotland. Many of the public houses were closed on the first and those which opened only remained open from 10 a. m. to 5 p. m. The Scotch are said to year they certainly consume plenty of whiskey. They may find pleasure in it at the time, but to an ordinary observer it is difficult to perceive where the fun comes in. It certainly won't be next morning. R. J.
