THE QUEEN'S FUNERAL.

LONDON, Jan. 27.—Preparations for the Queen's funeral are gradually assuming definite form. It promises to be the most tremendous pageant of a generation. The influx of members of royal families and representatives of foreign countries has been so wholly unprecedented that the court officials are finding it a difficulty to procure suitable accommodations. The procession is expected to occupy two hours in traversing London from Victoria Station to Paddington Station. The King as chief mourner accompanied by the Emperor William will ride horseback at the head of the procession with Earl Roberts and his staff in close proximity.

COWES, Jan. 27.—This morning Emperor William received from the hand of the Duke of Connaught his sword on his appointment as field marshal in the British army in the presence of the Households of the King and the dead Queen and a number of British and German naval officers. His Majesty has expressed his great delight at the appointment. Today he celebrated his birthday at Osborne, and received congratulations from members of the German Embassy in London. The Emperor, learning of the King's intention to appoint him a field marshal, sent the following telegram to Prime Minister Salisbury and Lord Roberts.

"The King, my august uncle, confers upon me the rank of a field marshal in his army and informs me that my appointment will be published on my birthday. I hasten to apprise you of my deep appreciation of so signal a mark of His Majesty's affection for me and I rejoice to think that I shall be numbered among those of the highest rank in His Majesty's gallant army."

(Signed) WILLIAM R.

In addition to the sword of Field Marshal the King has presented Emperor William already with the Knight of the Garter the insignia of the order in diamonds. The fact that the gift was ordered by the late Queen with the intention of presenting it on the Kaiser's birthday gave pathetic interest to the presentation.

LONDON, Jan. 18.—Yesterday throughout the Kingdom all places of worship held services in memory of the Queen. At St. Paul's Cathedral there was unusual silence. Before nine in the morning enormous crowds attired wholly in black streamed from all directions to the vast edifice. By ten o'clock it was packed and thousands were unable to get admission. The service began at half past ten. The most Rev. Frederick Temple, Primate and Archbishop of Canterbury preached a most touching sermon. All Roman Catholic and foreign churches in London held a special memorial service. Members of the French Embassy attended the French church and a very elaborate service was held at the chapel of the Russian embassy by command of Emperor Nicholas.

FATHER TIME'S OWN CLOCK

SET BY THE STARS, IT TICKS ITS SECONDS TO CLOCKS THROUGHOUT NORTH AMERICA

"The transmitting clock at the Naval Observatory, Washington, is the absolute monarch of American time-keepers," writes Evander McIver Sweet in the February Ladies Home Journal. "Every day in the year Except Sunday, by one pendulum-stroke it speaks directly and instantaneously to every city and considerable town between the peaks of the Rockies and the pines of Maine, saying to them that on the seventy-fifth meridian it is now high noon to the fraction of a second. A duplicate mechanism, stationed at the Branch Naval Observatory on Mare Island, performs a similar service for the people of the Pacific slope. And by this one clock at the National capital (together with its duplicate on the Pacific) is set nearly every time piece in the United States and Cuba, most of those in Mexico and many on the border of Canada. A number of clocks—from three to three thousand—in nearly every city and large town are wired together into a local family, and, by means of a switch-key at the telegraph office, are put into direct contact with the parent clock at the National capital. So that the instant the electric touch is given from Washington every clock in the circuit—whether it be at Boston, Minneapolis or New Orleans—begins a new day in perfect accord with its mechanical deity."

IN THE SUPREME COURT.

JUSTICE AND BARRISTERS TAKE THE OATH OF ALLEGIANCE.

FREDERICTON, Jan. 29.—The opening of Hilary term of the Supreme Court this morning was one of the most impressive events that has occurred within the court in the memory of the oldest living barristers.

The court room was deeply and tastefully draped. All the members of the court were present and there was an unusually large attendance of barristers, all in court costume. The term was opened by the usual proclamation by crier, except that the word "King" was submitted for "Queen" and the clerk's proclamation calling upon the sheriffs of the different counties to return the several writs, precepts, etc., directed to them in order that King's justices may proceed thereon.

The Chief Justice then stated that he desired that the oath of allegiance to King Edward VII. be administered to him, and after the clerk read the Governor General's proclamation this was done by Judge Hanington. The Chief Justice then in turn administered the oath to Justices Hanington, Landry, Barker, McLeod and Gregory and to Mr. T. Carleton Allen, clerk of the court. The oath was then administered by the chief's direction to the sheriff of the county of York, keeper of the King's prison, to Judge Wilson, judge of the York county court, and to the following barristers: J. D. Phinney, J. H. Barry, J. Howe Dixon, C. H. B. Fisher, Geo. W. Allen, John L. Marsh, E. B. Winslow, H. B. Rainsford, Havelock Coy, A. J. Gregory, F. St. John Bliss, C. E. A. Simonds, R. S. Crockett, Ernest McKay, A. R. Slipp, Peter Hughes and H. F. Alward, the first five named being King's counsel and then to the crier, Mr. John Gill.

The Chief Justice then delivered an address, which all those who heard it agreed was one of the most eloquent and impressive speeches that has ever been heard in Fredericton.

His Honor paid a just tribute to the excellence of the Queen, and spoke of the love and affection felt for her by the people of New Brunswick as well as the rest of the Empire.

Mr. J. D. Phinney, K. C., spoke for the bar. In concluding his speech he said: "While mourning the departed sovereign, we join with the bench in proclaiming our cheerful allegiance to the new sovereign and our loyal and hearty wishes for long life and prosperity to King Edward VII."

Judges and barristers added "God Save the King," whereupon Judge Wilson started the National Anthem, which was heartily joined in by all present.

The court then adjourned till next Tuesday morning, when the Chief Justice announced, the docket would be taken up immediately after the hearing of common motions. All barristers were requested to appear in mourning costume with badge of crepe on sleeve.

MONTREAL, Jan. 26.—As a result of three big fires within a week, in which the estimated loss exceeded three million dollars, the fire insurance underwriters met this morning and increased insurance rates fifty per cent on mercantile risks. Not only that, but they established a conflagration district, which includes the entire wholesale district of the city, and levied an extra 25 cent per hundred on mercantile property situated therein. Certain preferred risks are exempted from the 50 per cent increase, but all are subject to the conflagration risk. The action of the underwriters was largely determined by the necessity of improving the fire brigade, which lacks much necessary apparatus.
