


ROBBERY AGAIN.



COCAGNE MAN'S DEATH .- Mr. Thomas E. Johnston, of Winthrope, Mass., died at his home on Sunday, 14th of April, after an illness of over a year. Deceased was 71 years of age, and was son of the late Andrew Johnston, of Cocagne, N. B. He was a carpenter by trade and formerly worked in Moncton as ship carpenter, afterwards going to Massachusetts, and finally locating in Winthrope where he has fived for the last 20 years. He was married three times, his first wife being Caroline McKenzie, of Lewisville, N. B., and sister of Mr. John McKenzie, of this city; his second, Henrietta Perrigo, of Salisbury, N. B., and his third, who survives him, was Jennie McDonald, of Murray River, P. E. I. He leaves two children by his last wife, Malcolm and Cindy, te mourn the loss of a kindly and affect. ionate father. The funeral took place on Tuesday afternoon at the cemetery in Winthrope.

SUPREME COURT.-At Fredericton last week judgment was delivered in the following case: King v. Wilson ex parte Irving,-judgment was delivered by the chief justice. The facts are that one Boudreau was convicted by a magistrate of the county of Kent of selling liquor contrary to law. The defendant, who lived very near to the boundary line between Kent and Northumberland, claimed that he lived in the latter county, and that a Kent county magistrate had no jurisdiction. Application was made to the county court, Judge Wilson (?) for discharge of the prisoner under habeas corpus, who made the order discharging Boudreau from custody on the ground that the defendant lived in Northumberland County. The opinion of the court was that the magistrate had a right to rule that Boudreau lived in Kent and to convict, and that Judge Wilson had no jurisdiction. Judgment was for rule absolute to quash, Gregory no part, rest of bench agreeing in judgment.




