

LETTER FROM THE CAP-TAIN OF OSSUNA.

THRILLING EXPERIENCE OF CAP-TAIN AND CREW-STARVA-TION AND DEATH STARED THEM IN THE FACE.

DEAR SIRS:-After leaving Richibucto we soon got strong easterly winds and between Magdalen's and Cape North a strong N. E. gale so I ran her through the gut of Canso and everything went well until Sunday. 15th June. At noon of that day we were under two lower topsails to a gale from E. N. E. and a very cross contrary sea but as the pumps were sucking we did not anticipate anything serious as she had not made much water up to that time. At 3 30 p. m. after shipping some very heavy seas she turned over on her broadside and with difficulty we climbed on to her side all except the poor steward who I think, must have been struck by some of the wreckage as she turned over and the poor fellow was drowned. We managed to cut the backstay lanyards at the main when the masts broke and she righted. But, Oh! what a sight. The forward house was completely gone and the after house clean gutted and unroofed, nothing left but the two sides, boats and everything on decks gone. After she righted we made ourselves fast by ropes to prevent the seas washing us away and spent the night. The next day. Monday, it moderated a little and we found the water cask which was lashed to the inside of after house in the corner and well bunged was 4 full of water and we found some Richibucto biscuits (which I had transferred to a tin) floating about on the lee side among the wreckage also some matches floating about. The next day, Tuesday, the sun came out and by using a piece of glass for a lens managed to ignite one of the

matches and made a fire to dry us up. Yesterday, Wednesday, this steamer bore down on us and took us off, and the poor "Ossuna" was an awful sight, clean swept decks, stove in decks, masts gone and the water washing out of her stove in sides. However, we have been fortunate in being picked up by a most humane captain, who is doing all he can for us, and we are practially destitute. We are all now quite well, and only regret the poor steward being lost.


