KENT COUNTY COUNCIL.

AFTERNOON SESSION.

January 16, 1902. Council called to order at two o'clock.

Coun. McKee asks the indulgence of the Council until two o'clock to-morrow, to put in his report for the wharf committee as he is unable to have it ready this afternoon, on account of not being able to see some parties. Granted.

It was moved by Coun. Richard, seconded by Coun. Johnson, and resolved, that a committee of three be appointed to investigate the Treasurer's account of the financial position of the county, to report Saturday morning at ten o'clock.

Couns. Poirier Roach and Clark were elected as a committee for this purpose.

Coun. Peters submits his report as chairman of the Debenture committee. After duly advertising for tenders in the "Royal Gazette," the "Daily Sun," and "Daily Telegraph, several tenders were received, and the committee disposed of \$16,000.00 in new Debentures, bearing interest at 4 per cent. and running 25yrs., and with the proceeds paid all outstand. ing interests of Kent County debentures, \$16,000.00.

It was moved by Coun. Barrieau, seconded by Coun. Johnson, and resolved that this report be accepted, and that the old debentures be looked over by the Finance committee to see that they are all there and afterwards destroyed.

Coun. Johnson again brought up the matter of the Auctioneers and Pedlars. Quite a discussion followed taken part in by Councillors Clark, Hebert, Johnson, Lockhart and Morton. A motion was made and withdrawn.

Mr. McKee read a petition from a number of rate-payers in St. Anne, in the Parish of Wellington, complaining that cattle and pigs were allowed to run at large, near the Roman Catholic Chapel causing much annoyance.

It was moved by Coun. McKee, second ed by Coun. Richard, and resolved, that they have the right to-morrow afternoon to bring in a bill, amending the by-laws for the parish of Wellington. Carried.

Coun. Peters, on motion read a com. munication from the Rexton Agricultural Society, asking protection from the Coun cil against dogs killing their sheep. Coun. Perers said that the object of the petition was to have the Council see that the dog tax was collected so that there be a fund for this purpose.

It was moved by Coun. Peters, seconded by Coun. McKee that the Council adjourn until ten o'clock to-morrow, to allow the Finance Committee to go into session.

### INTERPROVINCIAL TRADE IN LIVE STOCK.

Trade in live stock between Eastern and Western Canada has been growing rapidly within the last few years. This increase of trade has been remoted, and in fact made possible, by the wise and generous treatment of the C. P. R. During the month of December and the first eight days in January, forty-six cars of grade and pure-bred cattle were shipped from Eastern Canada to British Columbia. These cars contained 2,223 head, and cost in the East something over \$30,000.00. Besides these, a considerable number have recently been sent to the North West Territories, and orders are now in hand for additional shipments to be made to the last mentioned Territory. In order to promote this trade, which has proved very profitable in many districts in Eastern Canada, farmers should use first class Shorthorn bulls. By careful selection and wise treatment females sired by such bulls will prove excellent dairy cows.

It is a noticeable fact that seven-tenths of the stock used for dairy purposes in Great Britain are Shorthorns and Shorthorn grades. Probably the most suitable dairy cow for the average farmer is a Shorthorn-Ayrshire cross. Steers whose dams are strong grade Ayrshire cows if got by a Shorthorn bull prove excellent feeders and very desirable shipping cattle.
