

MISCELLANEOUS.

SYDNEY AND ITS INHABITANTS.—Sydney, from the Cove, has the appearance of a considerable town standing upon an eminence. The buildings, streets, &c. do not, in general, remind a person of its recent origin; nor is there any deficiency of accommodation and comforts there more than a country town in England. It is increasing very fast. The small houses that the settlers erected are every where given way to larger structures of hewn stone, and warehouses of considerable magnitude are rising up near the water side, indicating the prosperity of the merchants as well as the rapid increase of population. On every side of the town, houses are being erected on new ground; steam-engines and distilleries are at work; so that, in a short time, a city will rise up in this new world equal to any thing out of Europe, and probably superior to any other which was ever created in the same space of time. The less I say of the society the better. As in all small communities, there is a jostling of interests and a contention for precedence and power that generate parties, which are kept alive by unprincipled individuals, who, having sprung from nothing, and having no character to lose, delight in reducing others to a level with themselves. Let it not, however, be supposed, that I allude exclusively to those who have been involuntary exiles, some of whom, both in their dealings and general conduct, are highly respectable. The greater share, I believe, of the convertible property of the colony rests with this class; and they, therefore, possess, to the various transactions of life, that degree of influence, both good and bad, which property may be supposed to give them in such a situation and which too frequently render them the objects of the envy and jealousy of certain of the voluntary exiles, whose principles and conduct leave them little to boast of in any state of society.—*Dawson on the present State of Australia.*

SUGAR.—The quantity of sugar at present consumed in Great Britain may be estimated at 160,000 tons, or about 360,000,000 lbs.; which taking the population at 16 millions, gives, at an average, 22 1-2 lbs. for each individual. In workhouses, the customary annual allowance for each individual is, we believe, 34 lbs.; and in private families the smallest separate allowance for domestics is 2 lb. a week, or 52 lbs. a-year.

VOLCANO.—Letters from Sicily give lamentable details of the late eruption of Mount Etna. Eight villages, not one of which was ever before affected by the flames or lava of the volcano, have been buried under enormous masses of stones and cinders. The coasts of Calabria, and some parts of Italy, exposed to the wind, had been covered with the same red dust as the vicinity of Etna. The country round the volcano has been completely desolated.

IF YOU WON'T I WILL.—A laboring man, named Squires, who resided at Wonford, in the parish of Haviltree, hung himself in his bedroom on Saturday evening. Report says that he arrived at his home in a state of intoxication; and on his wife accusing him of being drunk, which he denied, and saying she would rather hang herself than live with such a man, he turned the tables upon her by hanging himself.

PHOSPHORUS.—This chemical body may be purified for a variety of processes connected with the arts, by merely placing it in a piece of chamois leather. After closely tying it in the leather, it should be immersed in a vessel of hot water. The phosphorus melts almost immediately, and when in a fluid state may be pressed through the leather in a pure state. As a measure of precaution to the experimentalist, it may be proper to add, that the leather should in no case be raised from the surface of the water, till the whole of the phosphorus be driven through.
