WAYS AND MEANS Continued.

Mr End contended that the reason for the bight duty on brandy in England was, that it was a foreign manufacture, and it was therefore intended to diacourage the home manufacture of brandy, and the consequent use of grain. He was for raising the duty last year, but from enquiries he had since made, he had found that the duty had lessened the revenue, by inducing smuggling; and he was therefore more arrainst it

Mr SLASON thought the duty already high.
Mr GILBERT thought the additional duty highly necessary, and would also go for an increase on rum, if it should be proposed.

Mr Cunard insisted that raising the duty on bran-dy would lessen the revenue, and bring bad brandy into the country.

Mr CHANDLER thought Mr Cunard had wandered very much in his ideas on the subject; and that the hon. member's argument was most absurd. He (Mr Chandler) always understood that where duties were indiscriminately imposed, they would have the tendency to cause the best quality of the article to be im

Ported, because it would pay the duty better;

Mr Cunard charged the hon. member who spoke last, with always perverting and misconstruing his (Mr

Cunard's) arguments.

Mr Kinnear argued in support of the resolution, on Mr Kinnear argued in support of the resolution, on the ground of improving the morals of the community by throwing every impediment in the way of intemperance, and on the presumption that it would be very difficult to smuggle brandy into the province.

Mr Speaker and Mr Brown spoke in favor of the resolution, and Mr Wyer against it. The question

Mr S. Humbert moved a similar resolution with respect to rum; which, after considerable opposition, was withdrawn.

Mr Simonds then moved a general resolution, to the effect that it was expedient to pass a bill to raise a revenue in this province, and to continue all the duties contained in the present revenue act, with the addition of a small duty on loaf sugar, and a small additional duty on brandy, and with a small reduction in the duty on oxen imported into the province.

Mr Partelow suggested that the words "and tempers in and Kent.

whisky" should be introduced into the resolution after the word "brandy"—The amendment was adopted without conscition.

Some desultory discussion they took place, on the whole resolution; some of the agricultural members objecting to the insertion of that part relating to the reduction of the cattle duty. Mr Chandler moved that that part of the resolution be struck out. The committee divided on the question which was negatived. The original resolution, with the amendment as to Whiskey, was then put and carried.—The Chairman, (Mr Dow,) then left the chair, reported the resolution and obtained leave to sit again.
