London, Nov. 16 - We see no reason to alter the opinion which we expressed yesterday as the favourable appearance at Sunderland. The only Medical Board sitting at the time was the Board of Health, and the Board of Health has since made its report.

Happily, however, on the showing of the report, the di ease, be it what it may. Asiatic or European, Continental or home-bred, so far from exhibiting that frightful mortality which has haunted the imaginationand only the imagination—of the public for some time past, is evidently not more fatal than the ordinary cholera of this country, and therefore not of a nature to excite alarm. The report announces two deaths, and eight recoveries; and it will be seen that the general amount of cases has diminished, instead of increasing -the total number of sick, which by the former report, was 24, being now but 16.

W. Temple. Lord Palmerston immediately wrote to the King tendering his resignation. An explanation with Earl Grey was brought about Mr. Temple was promised an advantageous appointment and the parties were reconciled

Mr. O'Connell has announced his intention of forming a Grand National Union on such a broad and extensive basis as will embrace all sects and parties, and give expression to the sentiments of the people of this Country at large .- Dublin Morning Post.

The Lord Bishop of Calcutta died on the 7th July.

On the subject of the Cholera, people's minds have become so much more calm, from the very small number of new cases at Sunderland, and the uncertainty as to their actual nature, that it is ceasing to occupy any attention. The King of Holland, too, is little regarded, as it is seen that his only alternative, if he does not accept the treaty, is that of having all the Powers represented in the London Conference, parties to an alliance with Belgium against him. The only new feature of city affairs is, the beginning of a distrust, as yet but slight and partial, with regard to the continuance of the Ministers in office, and consequently, of the final success of the Reform Bill, Though confined at present to very tew persons, and not acting in any degree on the value of the public securities, the feeling upon the subject is very strong, and will soon manifest itself in a different manner if something does not transpir in the course of a few days to remove these apprehensions .— London Times, Nov. 15.

NEWCASTLE, Nov. 11 — The report of the party sent to Sunderland was, that the district they visited was seldom or never in a more healthy state; the reports, and also the opinions of the medical men on the subject of the cholera, are various and conflicting. I think the Sunderland cholera makes a great deal more noise at Newcastle than it does here, and perhaps more at London than at Newcastle. Several cases of cholera appear to have occurred, but the opinions are Flerent as to whether they are native or foreign. It does not appear that any more occur than usual at this season of the year; and they are generally persons who have been in a declining state, or of irregular habits; and but for the prevalence of that disease on the continent, would, mall probability, have been unnoticed.
