both the troops at Porto Santa and the blockading tervals: Between 11 and 12 o'clock, John Erringly from Madeira: also that they were joined by many deserters from the latter island.

A gentleman is in town, who came from Lisbon by way of France, having left on the 19th ult., and who affirms that both the French and English agents in Lisbon have notified to their Governments in an official manner, that many of the pricipal officers holding commands in Miguel's army do not dissemble their intentions of joining Don Pedro as soon as he shall make his appearance. This statement comes through a reepectable channel, and, if confirmed, little doubt can

remain of the ultimate success of the expedition.

Accounts have been received from Napoli di Romania, according to which the independent portion of the Greeks have manifested the most decided aversion to the choice made by the three protecting Powers of the Infant Sovereign, Prince Otho of Bavaria. The idea of being governed by a beardless boy, quite a stranger to the country, to its manners, its language, and its religion, could surely not be pleasing to such a race as the Greeks, especially after it had been reported that the choice was suggested by the late President, Capo d'Istria, and pressed for by his brother, the actual President, and the party who enabled him to usurp and retain till now the reins of the chief government. The retain till now the reins of the chief government Congress of Megara met in extraordinary session on the occasion, and it was unanimously resolved to send a protest to the three protecting powers against the selection made of Prince Otho. It is added, that the Congress, moreover, decreed that all the forces at its command should immediately march against the seat of the Capo d'Istria Government, and establish a national one in heu of it, and that 9,000 men had con-sequently taker the field If Greece is not, by some means or other, entirely liberated of the Capo d'Istrias and their influence, surely there will never be any peace in that country.

London, Thursday Evening half-past seven.—The express from Paris states, that M. C. Perier had chased to live M. Girod De L'Ain, late President of the Chamber of Deputies, is appointed Minister of Public Instruction.

A notice from Lord Palmerston respecting the blockade of Madeira, was posted at Lloyd's this morning, which recognises Donna Maria as the legitimate Queen

of Portugal, by the British government.

The Cholera has sensibly declined in Paris; but its ravages, both in the capital and in the provinces, are still fearful. The report for Paris of Wednesday gives 281 deaths. The entire number of persons more or less severely attacked has been stated in some accounts, as high as 50,000. The exact number of deaths is not known; it cannot be much, if at all, short of 15,000. It is remarkable, among all the sickness, that only three English residents at Paris are re. The last persons of rank attacked were General Labaug and Count D'Argout; they have both recovered

The Ancona expedition is at length amicably settled, by an arrangement between Cardinal Bernetti and Count St. Anlaire. The French forces will evacuate Italy, and simultaneously with them the Austrians will retire. The peaceable termination of this puzzling affair is a very good comment on the warlike announcement of the Constitutionel.

The 'strike' of the pitmen continues. A very pnmerous meeting of the infatuated men took place on the Black Fell on Saturday, for the purpose of entering into a resolution to support each other in their stand against their employers. The terms of the men's confribution are now becoming materially enhanced. From being a few shillings per man, to the unemployed, the sum is now precisely one-half of what the men at work earn by their labour !- Durham paper.

A bound pitman who did not belong to the Union, was shot on Saturday night last at Hetton, by some of the unbound men! The pitmen were under obligation by their bonds to quit the houses they occupied on Thursday the 19th April. Not having fulfilled their agreement, about twenty families were ejected by a body of London Police officers on Saturday, To this no resistance was offered. In the course of the evenng, the men assembled to a considerable number in the front of the cottages thus vacated; large fires were kindled, and guns and pistols were discharged at in

It now remains to be seen what effect the unanimous decision of the five great Powers of Europe will have on the disposition of the refractory party.

EMIGRATION. - The following is the official reply of the Colonial Office to queries which it answers:—
The provisions for sick or destitute persons, or orphan children, arriving in the North American Colonies, depends upon the charitable institutions for the purpose which exist in those colonies. In order, how to prevent the improper discharge upon the colonial charities of people burdensome at home, no relief is afforded to grown persons who were infirm or disabled previously to their embarkation for this country. The Governors of the several North American Colonies, have been instructed to find employment on some public works for persons who may not be able to obtain private engagements. This has been done as a mea-sure of precaution against an evil which is very unlikely to arise; and there has not yet been an instance, among the very numerous emigration of late years, of the emigrants of the season not finding work through the ordinary demand for labour in the Colonies. In New Brunswick, the construction of a great road is about to be undertaken by government, on which em-grants will be offered employment on very advantageous terms.
