NOVASCOTIAN. Specie.—For some time past the Deputy Commissary General has, we believe, been drawing upon the Bank of Nova Scotia for specie, to pay the troops; in consequence of the trifling demand for Bills of Exchange. The Gannet, which arrived here on Saturday last, brought out a supply of money amounting to £100,000.

NEW-BRUNSWICK.

FREDERICTON WATCHMAN. Wesleyan Academy.—A Meeting connected with this subject, was held in the Vestry of the Wesleyan Chapel, yesterday. It appears that the amount already subscribed exceeds £730, the greater part of which has been obtained in Fredericton alone. The meeting unanimously resolved, that an instalment of 25 per cent of the subscriptions should be paid into the hands of the Treasurer, early in the ensuing month, to provide for the payment of land. It is intended that a general effort shall be made throughout the Province, preparatory to a meeting of the District Committee, to be held in Fredericton the first week in October next.

FIRE.—We regret to state that on Tuesday morning last, the Carding machine and Saw Mills situate in Prince William, owned by Messrs. J. C. Joslin, & C. C. Bradbury, were totally consumed by fire. The manner in which it originated was, we believe, purely accidental, and the flames spread with such astonishing rapidity, that before any efficient assistance could be obtained, the property was totally consumed. We understand that there was about 2,300 pounds of wool in the Carding rooms, which comprised the stock of almost every family in the neighbourhood, all of which is irrecoverably gone. This, at the present season of the year is an irreparable loss, and we are sorry to hear that many individuals whose circumstances are very destitute, are among the sufferers. The loss is said to exceed £700.

ST. JOHN OBSERVER. The fine new whale ships *Thomas Millidge* and *Peruvian*, and several other ships were towed out of the harbour yesterday, by the steamers *Maid of the Mist* and *St. George*. The whalers proceed to the Pacific Ocean, attended by every good wish that their voyages may prove highly successful. A number of vessels have been both wind and fog-bound for six or seven days past, which unpleasant weather still continues in full force.

4 o'clock.—We are happy to state that the fog has left us, and given place to a clearer sky.

We understand with much pleasure that the Corporation Gold Medal, voted by the Common Council of this City to the Young Gentleman who should be pointed out by the Preceptor of the Grammar School as his best scholar, has been awarded to Master Edward F. B. Boyle.

AMERICAN CABINET.—Changes have again taken place in the American Cabinet. Mr McLane, Secretary of State, has fallen out with the President, and retired from his office.—Mr Forsyth, Senator from Georgia, has been appointed in his place. The nomination of Mr Taney, as Secretary of the Treasury, having been rejected by the Senate, Mr Woodbury has been removed from the head of the Navy Department to preside at the Treasury, which the Senate has approved. Mr Dickerson, of New-Jersey, recently appointed Minister to Russia, has been nominated Secretary of the Navy.

The Senate has rejected Mr Stevenson, as Minister to London, and it is now said that Mr Cass, at present Secretary at War, will be sent to that Court, and Mr Swartwout, Collector of the Customs at N. York, called to fill the consequent vacancy in the War Office. Other politicians assert that Mr Stevenson will be sent to London at all hazards; and that Mr Taney is also to be provided with a foreign mission.

Tribute to Lafayette.—At New-York on the 27th ult. there was a great Procession, in honor of the memory of General Lafayette. The various military corps, and the numerous mechanical and other Societies of the city, united in rendering the last tribute to the honor of the departed General, and the New York papers state that there has never been witnessed in that city such an imposing scene, since the death of Washington.

The cholera has broken out in Cincinnati, and several cases had proved fatal.

ST. JOHN COURIER. The correspondent of the New

York *Courier & Enquirer*, at Washington writes:—

The corvette which arrived at New York, brought an explanation from the French King—the substance of which is, that the chambers will convene early in autumn, and undoubtedly will make the necessary appropriations for carrying the Treaty into effect. This assurance has lulled the storm at the *white house*; a storm which ought never to have been raised, and which every thinking man knew must subside without producing the slightest result. By the French negotiation our merchants are to receive, when the treaty is carried into effect, five millions of dollars, as a full and ample compensation for fifty-one millions of dollars injury inflicted on our commerce, appears by official documents on the tables of Congress. By the British negotiation, we have almost annihilated our trade to the West Indies, in American bottoms. In truth, the whole system of General Jackson's administration, in every department has been a system of political quackery and juggling.

ST. ANDREWS' STANDARD. We understand that Thomas Jones, Esquire, of St. George, has been appointed Sub-Collector at West Isle, to supply the place of Edmund F. Stewart, Esq. who proceeds to Newfoundland.

CANADAS.

QUEBEC GAZETTE. By a Proclamation dated the 11th instant, the Court House of Quebec is appointed as the place of meeting of the Physicians and other medical men on Monday the 7th July, at ten A. M. for the election of twelve of the faculty, who shall constitute a Board for the examination of persons to practice or to be admitted as Students. The election of this Board by all the resident Physicians of the District, those of the Army and Navy excepted, takes place every third year. Similar elections take place for the other Districts.

The number of sick in the new Hospital, Blue Store, King's Wharf, supported by private subscriptions, under the superintendance of the Emigrant Society, amounted yesterday to twenty. Of this number, we were informed, fourteen or fifteen were cases of typhus fever. The hospital is now upon an excellent footing, and the sick receive the best treatment. No deaths have occurred since the opening of the establishment. Some cases of fracture from accident, and one man labouring under insanity are also in the hospital.

The weather of Monday and yesterday was warm and the thermometer rose to near 80°. The nights have, however, continued cool. In several situations frost was observed in the last days of the past week. The potatoe stalks, and even the leaves of the forest trees, were blackened by it. The grain is, generally, healthy and promising well, but it is backward; and the season still partakes of the variability which have characterized it so far. This afternoon we have a cold easterly wind with rain.

We are glad to hear that the *Oxur de Lion*, Captain Sumpton, now discharging, has suffered trifling damage in the interior of her hull from fire. The new sails stowed below, have been all destroyed. Part of the cargo has received considerably less damage than was expected. The wheat removed is in passable order, and the flour and ashes under this part of the cargo, it

is also supposed, are not damaged in a greater proportion. She is expected to be ready for sea in about a fortnight. The report of her having been scuttled, and the fire having originated by the negligence of a boy, as well as a cabin boy missing, are all unfounded.

The competition in steam-boat fares at Quebec, was more than usually active on the night of the 21st June. We believe that steerage passengers were conveyed up to Montreal, (a distance of 170 miles) for *nine-pence*. The boats which ran in opposition with the *Voyager*, belonging to the Tow Boat Company, and the *Canadian Patriot*.

Extract of a letter from Upper Canada—"The sales of Crown Lands in Hamilton, were 11,000 acres, disposed of by public auction, at prices ranging from 15s. to 23s. per acre. Proceeds £12,000—one fourth paid in cash. By much the greater part of the purchasers were emigrants who had arrived this spring via Quebec."

A few days ago, an Italian Minstrel was arrested on the Ottawa river, on suspicion of having committed a robbery, from having, when in liquor, exhibited a number of Bank bills of 100 and 50 dollars, amounting altogether to 800 dollars, which he wished to exchange for gold: the bills were also suspected to be forged. On enquiries in Montreal they were discovered to be good, and the man has been enabled to satisfy the Magistrates, that the money he possessed was the wealth he had acquired during ten years absence from his home, during which he had traversed almost every part of this Continent, with no other means of acquiring money than a monkey and a hand organ.
