In ceaseless beauty aye, The flimsy clouds unheeding As ye tread your wondrous way.

I perceive by the public prints, that the enterprising edizens of St. John are about applying to the Legislature at the approaching Session, for an Act to incorporate a new Bank in that city, apon the Scotch System of Banking, and that the good people of Frederiction, also opening their eyes to the advantage of a new Bank, are about seconding the views of the projectors, by also petitioning the Legislature for the same purpose, and to have a provision introduced into the act to establish a Branch thereof in Fredericton—a very proper measure in my opinion; and by the same token is it not worthy of the consideration of the inhabitants of Miramichi and Northumberland, whether it might not be advantageous to this important part of the Province, that a similar provision should be introduced in favor of this place. It appears to me Mr Editor that the necessity of a Bank or a branch of a Bank in this part of the country, from the extent of its trade and commercial resources is folly greater than in Fredercommercial resources, is fully greater than in Fredericton—our whole circulating medium at present consists in Nova Scotia paper, Bank or Provincial, little or no specie is to be seen, and this paper so vitiated owing to the terms of payment, that it is from six to eight per cent. less in value than the face, and for many of the most important purposes of the country, it not pass at all. Now surely if our circulating medium must be in paper, it had better be in paper of our own Province, and in Notes of real value. That it is highly injurious and inconvenient, and I may add oppressive to the inhabitants of this County generally that this paper should be our only circulating medium, no one who will take the trouble to reason or think on the subject, will I suspect pretend to deny, although it may be and no doubt is matter of advantage and speculation to individuals, especially to those who in-Now presuming such to be the case, ought troduce it. not the inhabitants and our members especially to take some step, or adopt measures to put an end to so great an evil, and in what way may I ask can this be so effectually accomplished as by getting a branch of the anticipated new Bank established here, this would at once afford us an abundance of Bank paper of our own Province, of real instead of fictitious value, and reduce our Currency to a wholesome state. This paper would soon be quite as current in Nova Scotia paper, would soon be quite as current in Nova Scotia and Prince Edward's Island as specie, and answer the purpose of paying for the supplies and importations from those places quite as well; and infinitely better than the Nova Scotia paper, in which all our remittances are now made; and equally well in the Canadas—as we can with this paper purchase Bills of Exchange on Britain, and remit these Bills to the Canadas in payment of our imports therefrom; this is precisely in payment of our imports therefrom; this is precisely in payment of our imports therefrom; this is precisely the way in which our remittances are now made only that the Bills are paid for in Nova Scotia paper. Time will not permit of my enlarging further on this subject at present, I may probably trouble you with a few further remarks next week, mean time I hope you will do me the favor to publish the foregoing hasty observatious, with the following short extract from Adam Smith's treatise on Banking, which, perhaps, may not be inapplicable at this particular crisis. If what I have said should have the effect of a public meeting of the inhabitants being convened for the purpose of taking this highly important subject into consideration, my present object will be accomplished.

It restrains the circulation of each particular company within a narrow circle, and reduces their circulating notes to a smaller number. By dividing the whole circulation into a greater number of parts, the failure of any one company, an accident which, in the course of things, must sometimes happen, becomes of less consequence to the public. This free competition too, obliges all bankers to be more liberal in their dealings with their customers, lest their vivals should carry them away. BANKING .- This is a subject which has created good deal of discussion of late, both in the public prints and in the domestic circle. The great difficulty merchants in this place labour under in procuring specie, and such paper as will be taken at the public offices, for duties, and the high premium they have to pay for the same, has had a most ruinous effect on the revenue; the falling off this year, owing principally from the above cause in this County, is estimated at £1000. This is a subject of vital consequence to the Province, and well deserving the serious consideration of the Legislature, and calls loudly for their immediate interferance. From our own knowledge we can state, that several persons who were formerly in the habit of porting, both from the Mother country and Halifax, dutiable articles, have abstained from so doing, owing to the causes above stated.

The principal, we may say our only currency, is Halifax Bank, and Nova Scotia Provincial paper, which has been subject at all times, to a discount of five per cent. at the public offices, and then taken as a favor, but within the last six or eight weeks hey have refused to take them at the public offices in Fredericton, and many persons who remitted such paper for the payment of Timber Licences, in consequence of this refusal is now experience of the refusal is now the refusal in the refusal in the refusal in the refusal is now the refusal in the this refusal is now experiencing great inconvenience, and must eventually suffer much loss.

In another column will be found a communication on this subject, which points out in a more detailed manner, the evils resulting from the present state of our currency, and calls on the Members of this County, to use their exertions to procure a meeting of the in-habitants, so that the subject may be fully discussed, when such measures may be adopted as will remedy the existing evil.

This correspondent also points out the necessity of the establishment of a Bank among us, and an article which we copy from the Fredericton Watchman, etates the advantages which will result to every com-munity from a well organized Bank being established
