## PROVINCIAL LEGISLATURE.

EXTRACTS FROM THE JOURNALS. MARCH 8 .- That the sum of five hundred pounds, granted at the last Session of the Legislature to be ap-phed in aid of individual subscription towards the erection of a Bridge over Cocagne River be re-appro-Shediac and Richibucto, forty pounds fifteen shillings and six pence of this sum be paid by Dudley Perley, Esquire, the present Supervisor, to John W. Weldon, Esquire, the late Supervisor on this road, it being a balance due him on his Accounts of Expenditure on that road, as audited at the last Session.

To his Excellency the Lieutenant Governor, the sum of fifty pounds, for the road from Shediac to Richibucto.

To his Excellency the Lieutenant Governor, the sum of three hundred pounds, for the road from Richibucto to Chatham.

To his Excellency the Lieutenant Governor, the sum of two hundred pounds, for the repairs of the road from Fredericton to Newcastle. To his Excellency the Lieutenant Governor, the sum

of two hundred and twenty-five pounds, for the road between Newcastle and Ristigouche, one half to be expended between Foreign's and Newcastle: forty pounds of the residue to be expended in finishing the bridge over the confluence of the Middle and Little

Rivers, and the approaches thereto. To his Excellency the Lieutenant Governor the sum of £37 10s. for the Great Road from Shediac to Dorchester; and £37 10s. for the road from Shediac to the Bend.

"ARCHIEALD CAMPBELL. "In complying with the Addresses of the House of Assembly, of the 13th and 24th ultimo; the first re-questing detailed accounts of the Receipts and Expenditure of the King's Casual Revenue, for the year 1833; and the second asking for a statement of all Fees which had accrued to the Public Officers on the Civil List of the Province, for the same period, it was the Lieutenant Governor's wish and endeavor, to render the required information so complete and satisfactory, as to leave the House nothing further to desire, on that head: It is therefore with regret that he finds, by the Address of the 7th inst., that his efforts to give full effect to the wishes of the House of Assembly, have so far failed; and that numerous and voluminous accounts and statements are now sought for-some of accounts and statements are now sought for—some of which are of a nature, which, notwithstanding the most earnest disposition on the part of the Lieutenant Governor, to aid, to the utmost of his power, the de-liberalions of the House, on the great question now be-fore it, he yet feels himself compelled to decline fur-nishing. Guided, however, by feelings and conside-rations, which he trusts will be duly appreciated, he will take upon himself the responsibility of directing all such of the accounts and statements enumeraied in the last mentioned Address. State for the Colonies, dated 4th January, relating to the monies arising from the New Brunswick Land Company, would have most materially influenced the deliberations of this House, when in Committee of the whole on the 4th and 5th inst. in consideration of the propositions made by His Majesty's Government, dated the 30th September last, relating to the surrender of

the 30th September last, relating to the surrender of the Casual and Territorial Revenues. *Resolved*, That in the opinion of this Committee, as His Majesty's Government in consequence of the re-peated applications of the Assembly, had, by the said Communication of the 30th September last, stated the terms on which the controll of the said Revenues was to be surrendered to the Legislature, and that as the House of Assembly after full consideration had on the bith inst. agreed to accept the said proposal made in the said Communication, and had appointed a Com-mittee to prepare a Bill with suitable provisions to meet the views as in the said Dispatch were express-ed and understood, it is deeply to be regretted that the additional condition contained in the Dispatch of the 4th January now prevents this Committee recommending to the House to act further upon the said Resolution of the 5th inst.

Resolved, As the opinion of this Committee, that it is expedient to Address His Majesty on the subject of the aforegoing Resolutions.

And the Chairm an further reported, that he was di-And the Chairman further reported, that he was di-rected to ask leave to sit again, Ordered, That the Report be accepted, and leave granted. Mr S. Humbert from the Committee appointed to

wait upon his Excellency the Lieutenant Governor, with the Address of yesterday, upon the subject of His Excellency giving assent to the marriage Bill now before the House, without a suspending clause, reported, they had attended to that duty, and his Excellency was pleased to make the following reply:-

"Gentlemen,—'The question put to me in this Address. is, in my opinion, both unconstitutional and unparliamentary, and I must therefore decline giving any Pledge respecting a Bill which is not regularly before me."

Mr Allen from the Committee appointed to wait upon His Excellency the Lieutenant Governor, with the Address of yesterday, requesting copies of certain correspondence with the Right Honorable the Secre-

right assumed by the House of Assembly in this Ad-dress, of salling for the correspondence that may have passed between His Majesty's Government and the Representative of His Majesty in this Province, ap-pears to me to be subversive of the principles and spi-rit of the British constitution; and I feel that I should it decouple the constitution of the principles and spiill-deserve the confidence reposed in me by His Maesty, were I to hesitate in meeting so dangerous an encroachment, not only on the independence of the Executive of this British Province, but upon the Prerogatives of the British Crown, by a most decided and unqualified refusal?
