

the current being strong against them; they were in good spirits, tracking the boat along shore, when they were fired on from the bush.—Three men were killed, and four wounded; Mr. Lander was one of the latter. They had a canoe of their own, and at the time they were fired on the boat was aground, and to save themselves, they were obliged to leap into the canoe, and make the best of their way; they were immediately followed by five or six war canoes, full of men, keeping up a continual fire for five hours, until it got dark, when they lost sight of them; they arrived here on the 27th ult. Mr. Lander expired this morning; he wrote me a letter two days ago, requesting that I would take charge of the vessels and property belonging to the African Inland Commercial Company, with which I accordingly complied.—The ball entered near his hip, and worked down to the thick of the thigh. It was a most malicious and treacherous attack. Mr. Lander told me that they were Boony, Brass, and Benin canoes; so that from these circumstances I am of opinion that some of the slavers, or other Europeans, have been the promoters of this murderous affair."

COUNTY OF GLOUCESTER.—On the 17th inst. Jeremiah Martin, a Canadian, was committed to the Gaol of the above county, under a warrant from Perry J. N. Dumaresq, Esq. charged with having killed one James Bellair, on the day preceding, at Belledune, in the said county, about 30 miles from Bathurst; whereupon John F. Wheeler, Esq. one of His Majesty's Coroners, immediately proceeded to that place, accompanied by Robert Gordon, Esq. M. D. and early on the following morning held an Inquest on the body. It appeared in evidence, that the deceased and Martin had met on the evening of the 16th, at a tavern kept by one Joseph Logan, at Belledune, and, having drank pretty freely, had quarrelled: that Logan endeavoured to keep them quiet, and prevailed on Martin to retire to rest, there being a bed in a kind of loft overhead, Logan and Bellair remaining below: that the deceased and Martin still continued scolding, that at length the deceased attempted to get up a ladder to the loft, to renew the fight; that while in the act of ascending, Martin struck him on the head with an iron rake, which happened to be in the loft; that he fell, and languished in a state of insensibility until next day, when he died. Doctor Gordon having examined the body, deposed that death was caused by the blow—the Jury returned a verdict of Wilful Murder against the said Martin. Bellair was an industrious man, by trade a blacksmith, and has left a widow and six young children in a state of indigence and distress.

A Correspondent in Bathurst informs us that Dr. Bishop succeeded on Friday last, in restoring to animation, a Lumberman who unfortunately fell from a 'jam' of timber, and passed through the fall of the Nepisiguit river. Too much credit, we understand, cannot be bestowed on Dr. B. for his indefatigable exertions on the occasion, as well for the skill displayed, *three hours* having elapsed before he succeeded in accomplishing his praiseworthy task.

ON Saturday last the mate of the bark Calypso, of Bideford, lying in Bathurst harbour, unfortunately fell out of a canoe, alongside the above vessel, and was drowned.

FRESHETS.—We learn with much satisfaction, that the late rains have produced a considerable freshet in the rivers in this as well as in the neighbouring County of Gloucester. This will be of infinite service to the Lumbermen, in enabling them to bring to market a portion of the timber which has remained in the brooks, owing to the dryness of the season.

LATE PAPERS.—Our Correspondent at Bathurst informs us that a vessel, bound to Restigouche, came to off the bar of that harbour, the Captain of which might have brought Glasgow papers to the 23rd ult. This, we are sorry to say, is a circumstance, which too frequently occurs at this port. Upwards of 70 vessels have arrived this spring from Europe, and out of that number, not a dozen have brought papers. How to account for such inattention we are totally at a loss—it certainly cannot be the small sum a paper costs, this we would cheerfully bear. For strangers we can make every excuse, but for such masters as are yearly in the habit of trading to the Colonies, we can offer none, they being well aware how anxious we are at all times to hear from the mother country.

We have, however, to make some exceptions, and to such Masters as are in the habit of bringing papers, we wish to acknowledge our obligations, and shall feel most happy at all times to furnish them, while in port, with a copy of our Journal, and on leaving, with a file of Colonial papers.

INQUEST.—An Inquest was held this morning before John M. Johnson, Esquire, on the body of John Weston, a Sailor, who fell down in the store of Mr George Taylor, last evening, and instantly expired. Verdict—Died by the visitation of God.
