We have lately understood that — M^r Rae who was charged with having made an attempt to murder Peter O^Quin and wife at Margaree some time since, has been arrested and is now in custody to take his trial therefore. It is stated that he had nearly succeeded in making good his escape; but that Providentially the very means taken by him to prevent his detection eventually led to his discovery and apprehension. We believe Mrs. O^Quin's life is still in much danger from the wounds inflicted on her by M^r Rae.

SIR,—I have the honor to acknowledge the receipt of your Dispatch of the 6th ult. transmitting a joint Address to his Majesty from the Council and House of Assembly of Nova Scotia, praying that the protection may not be withdrawn from the Colonial Timber Trade, which it has received from the duty on Foreign Timber; and I have to acquaint you, that it is not the intention of His Majesty's Government to propose to Parliament any alteration in those duties, affecting the Trade of the present year; and, that no step will be taken without the fullest consideration of the Colonial interests involved.

QUEBEC, April 28.—The Montreal papers repeat the rumor in circulation here several days ago, that the house of the late Horatio Gates & Co. have suspended payments, since the death of the two principal partners. The Hon. Mr Moffat, W. Peddie, Esq. and Timothy Follet, Esq. of Burlington, Vermont, are said to have been appointed Trustees to the Estate.
