They designed to complete the cargoes of their vessels, and then wind up their affairs. Freights varied from £6 to £8, and even £9 per ton. DESERTION OF SEAMEN. THE desertion of seamen from the vessels in this harbour, more particularly for the last three years, has been an evil of the greatest magnitude, as it has very sensibly militated against the trade of the port; merchants in Great Britain being reluctant to send their vessels to a place, where their Captains are continually harassed by the desertion of their men, and they put frequently to great expense by the detention of their vessels when ready for sea, and the extravagant charge demanded by men, for the run

An Act was passed last Session to remedy the evil, and we have much satisfaction in having it in our power to record the conviction and punishment of one of these offenders, it being the first under the above law.
