two French priests, in charge of a considerable sum of ready money, with which they left on the 18th inst. by an Austrian merchant vessel for Beyrout. Their mission also was to the convents of Lebanon, and whilst in Alexandria their inquiries were particularly directed to the means of shortening the term of their expected quarantine, and conveying the money in safety to the mountains.

London, May 18.—The Timber Duties.—On Thursday a special meeting of the Chamber of Commerce was held in the Town Hall, to consider what steps ought to be taken in reference to the proposed alteration of the duties on timber. Rebert Kerr, Esq. president of the Chamber was in the chair. The chairman read the requisition calling the meeting, and also a minute of the meet-ing of the directors: Mr Kerr proposed a series of resolutions, condemnatory of the proposal contained in the budget for raising the duty on colonial timber. The motion was carried by a majority of seven votes; 33 voting for an amendment, and 40 for the motion.—Glasgow Paper.
