That whereas by the mode now generally pursued to provide for the suppor of the Poor in this County, many persons who might under proper regulations, contribute to their own maintenance have nevertheless became chargeable to, and are entirely maintained by the inhabitants of the Parishes in which such persons reside, to the great burthen of such inhabitants. And whereas the establishment of a suitable Alms House and Work House within the County would not only enable many poor persons who are now chargeable to the Parishes in which they reside, to would also afford the means of materially checking the disorderly behaviour of divers persous who by drunkennes and idleness, dis-qualify themselves from earningapreper support, That your Petitioners feel that the present
