Lady the Queen, held at the Court House at Newcastle, in and for the County of Northumberland, on Tuesday, the 11th January, 1842: Ordered—That no BULL or BULLS be

allowed to run at large in any part of the Parishes of Chatham or Newcastle at any season of the year, under the penalty of FIVE SHILLINGS for each Bull so found running

or going at large.
And forther Ordered—That it be the duty of the Hogreeves in the respective Parishes to take up and impound any and every Bull so found running or going at large in violation of this Regulation. And that such hogreeves be entituled to receive the sum of Five Shillings for each and every Boll taken up and mis pounded by them, to be paid together with the charge of the Pound Keeper, before the

same shall be delivered from pound.

And it is further Ordered—That a fine of Five Shillings be levied—on the owner or owners of each Bull so found running or going. at large contrary to, or in violation of, the foregoing Regulation, to be paid to the Overseers of the Poor, for the use of the Poor of the Parish wherein the said offence or viola-tion of the said Regulation shall be committed.
