" The present time is, we believe, unprecedented in this community, for ssarcity of money in circulation,-the general business of the Province is quite stagnant, and parties interested are like men hanging between hope and despair,-the spring, to which so many looked forward with sangaine expectations,

The tide of Emigration, from the mo-

ther country, is setting towards our shores, and this year a very numerous body of individuals have already arrived, and numbers are hourly expected; but there is no person appointed here, either to give such as wish to remain, any instruction or advice, or render them any assistance. This is not right. There is abundance of land, belonging to the Crown as well as to private individuals, which, if occupied, would conduce very much towards the improvement of the Province, and many farms remain untenanted, and consequently untilled, which would not be the case, were some one employed by Government, to look after the emigrants yearly brought here, and to make systematic arrangements for the disposal of public and private lands on this side of the Province. Many of the passengers have means, and would cheerfully, we feel persuaded, take up their abode among us, if pains were

" On their arrival at St. John, they should as this Province does, an extensive egricul. tural population, too much pains cannot be taken to secure the services of those Emiwho at present are people of sober, and generally speaking, industrious habits.'
