There has been no arrivals during the week, excepting a few fishermen, and only one or two vessels cleared at the Custom House.

## WEST INDIES.

H M Schooner Pickle, Lieut Montres-or, arrived at Kingston, in seven days Jamaica, January 10. from Carthagena, and brought the following intelligence:—H M S Vestal was lying at Santa Martha, and H M. schr Charybdis at Carthagena when the Pickle left. The latter vessel was fired at while at Zapota, by Carmona's squadron. Lieut DeCourcey returned the compliment, and in so doing killed the Admiral and about 40 of his men. The Charybdis did not lose a man, but suffered from injury done to her rigging and bulwarks. Carmona was still firing on Carthagena, so much so that Mr. Kelly, with British and American merchants, amounting to about 35, remained on board the Charybdis.

Why should the whole com-munity be put to trouble and kept in alarm because a few foolish boys were prevented from playing their drums and blowing fifes? And why should other lives be perilled because a few of our fellow citizens have unfortunately fallen? Let peace & quiet be first restored. This done, there is power and justice enough in the country to see the poorest man righted. Let the people not provoke the government and the authorities against them. It is madness to do so, it is madness to persist in any attempt to resist the authorities of the country, whose business it is to secure peace to all, without any reference to who is right and who is wrong.
