On the 17th M. Guizot declared that the treaty would not be ratified. He repelled the idea that the government would be more ready to ratify after the dissolution of the Chambers, and concluded with these words:—

"The line of conduct which I adopted two ments ago, in refusing to ratify the treaty, I will equally pursue, when the doors of this building are closed; and, in the actual state of things, I conceive that I should fail in my duty, were I to recommend the ratification."
