The Litany and anti-communion service being read in his usual impressive manner, by the Rev. the Rector of St. Paul's; the Rev. T. N. The Reverend gentleman's discourse was throughout, sound impressive, and appropriate, and was listened to by a very large and attentive congregation. God mereifully grant that every member of the Church did on that day 'take need how he heard.' On this occasion, the beautiful and soul-stirring occasion, the beautiful and soul-stirring Psalms of holy David, were sung in a very sweet and engaging manner, many members of the choir of Saint Paul's church being present and assisting.

During the reading of the offertory at the communion table, the devotions of the people were received and presented to the Visiting Missionary. The collection made on this day, although very liberal indeed (amounting to £18 6 is not by any means sufficient to meet the various pressing claims now due by the church; but may the spirit of God yet put it into the hearts of his servants to come forward and succour the Missionary in his work. Divine service was concluded with the usual prayers appointed to be read when the holy communion is not administered.

The Nova Scotia Legislature brought its business to a close on Saturday last.

LATER FROM CHINA. The ship Venice, Capt. Perit, arrived on Monday, at New York from Canton, whence she sailed on the 21st of November; she brings accounts some days latter than those we had on Friday, in the English papers. We have files of the Canton Press to the 20th, and of the Register to the 16th of November, inat Macao, the accounts they contain from Canton are to the 17th only

It was reported that Sir Henry Pottinger had demanded eight million of dol-lars as the ransom of Ningpo, and as-a bribe for letting alone Hangchowfoo, the capital, and other towns in that province. No reply hadas yet been received to this demand. The robbery committed at Ningpo-booty, they call it—is said to have been considerably productive.

Most of the plunder, however consisted of cash—the low metal currency of

the country-of which the amount collected is said to have been a million of dollars. Of sycee and s lver dollars but little was found. An immense quantity of rice also fell into the hands of the captors, which they were generously selling to the poor at half a dollar the

hundred weight.

The Emperor has been sorely troubled by the overflowing of the incorrigible Yellow River, inundating extensive and populous districts He has disgraced the high officers who had charge of the embankments, and appointed others who, he thinks will be able to keep the river where it ought to be.

The officer commanding on the Canton station had received orders to seize all junks laden with valuable cargoesthe appetite for plunder grows by what it feeds on and to harass the coasting trade as much as possible.

From the Canton Press of Nov. 20. Our latest accounts from Canton are of the 16th. Every thing remained quiet, and teas were being shipped off without interuption. But the high prices which we mentioned a fortnight since, as being paid for Congous, have not been maintained, and those then valued at 35%, may now be had for 31%. The scarcity of money is very great-the circulating medium consisting of Spanish pidar dol lars, which for some time past has been barely sufficient, was rendered much more scarce by the shipment of a large sum to India of the Canton ransom money, and is growing less every day by the destruction of these coin by the Chinese fashion of stamping them, while the defficiency can no longer be supplied by importation of the Spanish dollar, and those of the American republic have not

ret obtained currency here.

Fifteen hundred of the unhappy Chinese are said to have been slaughtered at Chusan. They fought with courage, but their poor skill could do little or nothing against the murderous science of the assailants. At Chinhae the slaughter is reported to have been 'immense.'

From Demerara.—Demerara dates to the 25th have been received. For six or eight weeks previous, the negroes had refused to work in consequence of a reduction of wages. Of the 150 estates in Demarara and Essequibo, there are not over 40 upon which any labour has been done since the strike The Governor visited the Greenfield estate, and addressed the labourers, but wi bout any beneficial effect.

Fredericton, 14th March, 1342. A new Bill for regulating the sale of Timber and Logs was also read a third time—this bill embodied the amendments made by the Council to the former bill, which amendments were voted a breach of privilege by the House, whereupon this new bill was brought in, embodying those very amendments! Mr Woodward moved that the passage of this bill would be a violation of the privileges of the House, and a sacrifice of its independence, as it was submitting to the dictation of another branch of the Legislature, To this Mi Weldon moved a long amendment, which was lost by the casting vote of the Speaker; then Mr Woodward's resolution was put and lost, and then the bill passed! Verily the present flouse of Assembly are a consistent body, and worthy to be admired? They vapour loudly about their independence, and say they will not submit to dictation from the Council; then they quietly put their independence in their pockets, swallow the dictation. and sneakingly submit to what the other branch say, shall be the law, for which the highest thanks of a truly grateful country are justly due to them. If the House were not checked and cuffed a little now and then, there is no knowing what they might do.
