to do anything for him. I made an incision about three inches below the right groin, and passed a probe about two inches in the direction of the abdomen, inches in the direction of the abdomen, where I conceived the principal cause of his suffering to be, but found no discharge. I again inserted the probe in the same direction, passing as near the Cruralis artery as safely would warrant, about two and a half inches further than the first altempt, when a great quantity of the foetid pus followed the withdrawal of the probe. I then stopped the orifice of the wound with prepared sponge tent—Spongia praeparata. I attended and dressed the wound twice a day for three days, when the swelling of the thigh was totally reduced, but the inflammation of the leg and foot still continued. The deceased then informed me that he had, about fifteen years ago, received a conabout fifteen years ago, received a con-tusion on his right leg, which he insisted I should open. I made an incision in the leg to the bone three inches in length the bone was but little deceased, but the flesh of the leg was one mass of corruption. I was then morally certain his ease was hopeless, and told him so in presence of many, who will in a Court of Instince patent to want I have stated Justice, attest to what I have stated. After this I attended the deceased twenty three days twice a day. When, by a fall from a carriage, my shoulder was dislocated, and the upper part of the os-humeri fractured, which disenabled me to give the deceased any more attention; but a young man, now in scudy with me, attended him until he died.

I may here observe that at the post mortem examination of the medical gentlemen, who attended at the Inquest, they found the head of the right Os Femoris, and the great Trochanter, and the lesser Trochanter much carioused and wanting, and in rapid progress of decomposition, which must have convinced, and no doubt did, every one who knew anything of the case, that poor Campbell's pulse ere many hours, must cease to beat for
