Yesterday the House went into committee of the whole on the Lumber Bill, upon which there was a regular field day; in its early stage, Mr. Hill moved that a proviso exempting lumber cut on the State of Maine, run down the St. John, and shinned in American vessels for the Haired the State of Maine, run down the St. John, and shipped in American vessels for the United States, from duty be struck out; which was carried; it then came out that without this proviso the Bill would be in direct violation of the terms of the late Trea y, and a motion was made to reconsider; a long and sharp debate now took place, and several members declared their lossility to the Bill because it effected winter. hostility to the Bill because it affected private property. Mr End said he was not surprised at the conduct of the hon member for Charlotte, [Mr Hill] as he stood in that House as the advocate of the United States—he had ever defended their interests. A motion was made to postpone the Bill, and the House divided 16 to 16! (Mr Stewart being the only Member absent), and the motion was lost by the casting vote of the Chairman, (Mr Partelew). A motion was then made to reconsider the vote re-lative to the proviso, and the same equal division took place, whereupon the Chairman de-

eided in the affirmative.

But the opposition did not give up beat yet; after the Committee had risen and reported they again divided the House, and mustered upon this dernier resort 14 to 17. The provisions of the Bill are as follows: The Province (by its Commissioners) are to negotiate a Loan of £70,000, either in this Province or in London; for which the Province pledges a duty of one per cent. on all imports for the payment of the interest, which it is sup-posed will not only do so, but realize a surplus toward the liquidation of the debt. The amount of Customs, &c. (said to be £15,000 annually) are also to be pledged as security, and the Bill to remain in force 20 years. The principal is to be paid in fourteen annual instalments of 5000t each; the first instalment to be paid in September, 1844, and the others to follow accordingly by the first annual in Faulance.

September, 1844, and the others to follow accordingly; but if the money is hired in England, the Commissioners are empowered to deter the first instalment until September, 1849.

It is supposed that the Loan will be taken in this Province; Mr Wilmot declared during the debate that he had authority for stating that a party in this Province were ready to do so.

I consider this Bill the most important that has passed, or that will pass during the session. The House having rejected the plans of the Executive, the prosperity of the country and credit of the Province depend in a great measure on the success of this Bill, and a system of future retrenchment and improvement.
