A WORK containing an account of the Topography, Climate, Soil and Natural Productions of New Brunswick, form a desirable object in Colonial literature. It is generally acknowledged that the historical sketches of certain districts of the Province; which have appeared from time to time, with all the merits they possess, do not supply a full description of the whole country in its present state, and the advantages it offers to a respectable class of emigrants from Great Britain.

The numerous able works that have been written on Canada have been the means of introducing the extensive improvements everywhere seen in that Province, compared with which New Brunswick possess equal advantage.—As the relief of the surplus population of the Mother Country and its transference to the unoccupied Lands of her Colonies is of national importance, the chief object of the above work is to supply a full and accurate account of the Province with a view to its improvement by British emigrants and British capital.

During the last fifteen years, the author has explored every district of Nova Scotia and New Brunswick. The last five years have been devoted to making a Geological Survey of the latter Province. His attention has also been directed to Emigration; and from the opportunities he has had for obtaining information, his descriptions will be given from actual observation, and his remarks will be derived from practical experience.

Besides adverting briefly to the History and Aborigines of the Colony, the work will contain an account of its present state, its climate, topography, agricultural, geology and mineralogy, fisheries and other resources, trade, statistics, and natural history, with remarks on emigration, and information for emigrants.
