CANADA. - The question of the removal of the Seat of Government from Kingston to Montreal, has been carried in the Assembly-yeas 51, nays 27. Of the proceedings in the Legislative Council, the Quebec Mercury remarks :-

"On Mr Baldwin's resolution in favor of the removal, being brought up by message from the lower house, it was moved that the subject be discussed on Monday. The hon Mr Morris moved an amendment condemnatory of the ministry, who thus endeavored to force the subject upon the house twice during one session.

The amendment having been lost and the original motion carried, the hon. Mr Morris instantly rose, as did the twelve honorable gentlemen who had supported his amendment, and entering a protest on the journals of the house, retired in a body, as it is rumoured, never again to return. The hon. Speaker also intimated his grief at so little respect being shewn to the former decision of the House, and his intention immediately to resign his seat."
