IV. The Phalanx will keep a general record of the progress of the doctrine of association, and of social movements in different parts of the world, and will furnish details and information in relation to the Associations now organized in this country, and of new ones which may hereafter be established.

It is designed to make the Phalanx the principal medium of communication between the associations themselves, and between them and the public.
