PROCEEDINGS OF THE LEGISLATURE.—By Kelly's mail on Saturday, we obtained the Journals of the Legislature up to the close of the session. We have given in another place numerous extracts.

The Sentinel makes the following correction in its summary of Legislative news, which we copied last week:—

"In part of last Friday's impression, it was erroneously stated that the Bill for amending the College Council, had been agreed to by the Legislative Council. It came down to the Assembly with an amendment, including the Bishop of the Diocese among the members of the College council. The honorable Mr. Wilmot was willing to make the amendment, but it was rejected by the House, as recognizing a dominant church, which will not be tolerated in these colonies, and as being an act of injustice to the Roman Catholic Bishop, and superior clergymen of other persuasions."

ANSWER TO THE YORK COUNTY ADDRESS.—The following admirable and feeling answer was given by Sir Charles Metcalfe to the address forwarded to him by the inhabitants of York county.

"The loyal and patriotic feelings which have induced you, gentlemen, to give expression to the sentiments conveyed in your Address, demand my warmest thanks; Looking back to the time when the ancestors of many of you sacrificed almost every other earthly good, in order to preserve, inviolate their allegiance to the British Crown, and their connection with their Father Land; every lover of his Country must be filled with admiration at such a splendid instance of loyalty and devotion; and it affords a proud enjoyment to see their sons and their sons' sons eagerly embracing an opportunity to manifest the same noble spirit, with a view to uphold Constitutional Government, and to maintain affectionate union with the mighty Empire, of which British North America is a cherished portion. No less do I appreciate the hearty operation in the same cause of those, who, born in the Mother Country, retain across the broad Atlantic, their undiminished love for their former home, supporting the honor of the Crown and the integrity of Her Majesty's Dominions, and transmitting the same generous attachment as an inheritance to their posterity."

"As long as these filial feelings pervade the people of these Provinces, British North America may confidently expect to flourish, prosperous, happy, and free; secured against danger by the energy and courage of her own children, and by the whole power of the British Empire, while the industry and enterprise of her inhabitants are adding daily to her wealth and resources, and to the enjoyment of nearly all the blessings that any country in the world can possess."

"Long may this be her happy destiny—long may her blissful union with the Parent State be the source of increasing benefit to both; and that you Gentlemen, and your Province, may have your full share of every advantage, is the fervent wish of an honest heart that loves the alliance of loyalty, patriotism and freedom under the Shield of the British Constitution."
