Ellis, sail maker, Holyhead, within a circle.

The barque Pons Æli, Mock, from Cork, reports that on the 23rd September, spoke the brig Warrior, of Irvine, 42 days out, in lat. 45 9, longitude 40 0 We t; and fell in with the brig Ratchford, dismasted, and on her beam ends; took off the crew and brought them to this port. On the 5th October, spoke the barque Douglas, of London, bound to Quebec, with loss of fore and mizen topmasts, 39 days out. October 7th spoke the ship Effingham, of Cork, bound to Quebec, 30 days out, all

Captain Leask, late of the barque Hants of Aberdeer, reports-that he sailed from Saint John on the 28th August, and on the 19th of September experienced a heavy gale of wind from the South West, when he hove too under a double reefed main-topsail, the sea running high, and breaking on board in all directions, the ship labouring very much, and making a great deal of water, he keeping the pumps going. At 1 o'clock, A. M., on the following day, the wind increased, and veered round to the South and Westward, when a heavy sea broke on board, shifting the deck cargo, boats, and everything on deck, the ship making much water, and finding the leak gaining on them, called all the crew to the pumps at half past 3. there then being 5 feet water in the well. At 6 o'clock the water had risen to 6 feet, and washed the cabin decks, and the sea making a clean breach over her. Finding that the ship was filling rapidly, and remaining any lonthe pumps was useless, the Captain decided on saving a little provisions, and to send it up to the tops-which was accomplished with much difficulty. All of a sudden the ship went over on her beam ends, the deck timber floating up in the lee rigging. The crew succeeded in getting out on her side, and cut away the main and mizen rigging. She then righted a little, when the masts, and every thing on deck gave way, stogether with the larboard rails, &c. The water then washed in and out of her top sides, and the wreck was towed astern. The crew remained in this perileus aituation, wet, cold, and hungry, until the evening of the 22nd, when the brig Pomona, of Alloa, Captain Templeton hove in sight, and at 8 o'clock at night spoke them, but being dark, and a heavy sea running, he could dot render any assistance. Seeing the perilons situation they were

in, he stopped by the wreck all night, and next morning with much difficulty, got out his boat, and took the Captain and crew on board his vessel, and brought them in safety to this port. Captain L. speaks in the highest terms of the humane manner in which he and his crew were treated by Captain Templeton.

The bark Augusta, from a port in Britain, bound to Quebec, with a cargo, put into this port dismasted, and is making her way up the

On the 19th September, the brig Trafalgar, Younghusband, from Maryport, experienced a heavy gale of wind from the southward, in lat. 47 10 W., longitude 39 30 W., which increased to a hurricane. At midnight carried away the main yard, and a great part of her sails. On the 20th, shifted her ballast. At 4, A.M., the wind shifted round to N. W., from which quarter it continued to blow very severe for 6 hours. On the 22nd, at 8, A.M., two vessels appeared in sight. They were the ship Victory, of Belfast, and the brig Torrence, of Quebec, bound for Quebec. The former had been struck by a heavy sea, which had carried away her rudder, masts, boats, swept the deck, and hove the ship on her beam ends. Took all hands off the wreck, 28 in number, and left the ship in a sinking state. The Torrence had lost her mainmast, fore top mast, all her sails, rigging and boats, and intended returning to England. Spoke the Flora, off and bound for St. John, N. B., with the loss of her boats, bulwarks, and part of her sails. On the 27th spoke the brig Lica, of Galway, from Drogheda, bound to Quebec, with loss of sails, and main-topgallant masts, and all his water, in latitude 44 35 N., longitude 40 W. Transferred, on the 22nd September, 6 of the seamen on board the Torrence for England; same day 9 on board the Flora for St. John. On the 5th of October, pu the Captain, officers, and 12 seamen on board the George of Waterford, bound to Quebec; on the same day, placed two on board the Hope of Maryport, bound to Quebec.
