Agreeably to the undermentioned Regulations, the sum of Nine Pounds Fifteen Shillings will be distributed among the successful competitors, in prizes differing according to the merit of the several candidates.

- 4th. No driver to be allowed.
- 5th. The particular ridge, or portion, assigned to each team, to be determined by lot.
- 6th. The size of the Furrow to be 8 inches broad, by 4 1-2 inches deep.
- 7th. The teams to be on the ground by half past nine o'clock, and ready to start by ten o'clock, A. M.
- 8th. The Judges to determine and announce before starting, the quantity of ground to be ploughed, the length of time allowed for the performance of the work, and any further conditions that may be deemed necessary.
