Hawana, Jan. 13th, 1846-Lieut. Peel, son of Sir Roberr Peel, arrived here in the last steamer from Vera Cruz, and went to Europe as bearer of dispatches from the Admiral of the English squadron at the Sandwich Islands.

Since his passage a rumour is circulated that the whole English force in the Pacific is making sail for the Columbia River, with orders to anchor there.-Journal of Commerce.

Among the slavers recently captured was the "Africano," which had on board 589 slaves of which 28 died on er passage to Freetown, and 30 more on the first night of her arrival. The latter were killed in a sanguinary fight, in which the crowded wretches engaged during the night. The Gazette has the following :-The offirer of the Navy, who brought the "Africano" to Sierra Leoua, stated that the towns of Lagos, on the slave
