Attached to the Church from principle, we hailed the formation of the Province into a Seperate Bishopric as an event emiuent in the prosperity of the Colonial Church.

### MILITIA MUSTERS.

Even under the modified infliction of his visitation, we are again called upon to sympathise with our neighbours of the masculine gender, and who are of power and ability to carry arms, under the calamity of having to abandon their agricultural and other pursuits, particularly of a labouring class, in order to perform this worse than useless penance, of attending Militia Muster. Were this grievance of a merely negative character (we would beg to be excused for the absurdity), it were not so much to be deplored and deprecated. It is true that in some cases, to young men and lads, with means of procuring horses or conveyances, and who can spare a few shillings to spend in beer (or anything stiffer that they may wish to indulge in), cakes and sweeties, Militia Muster presents a holiday and source of fun. frolic, and FREEDOM FROM RESTRAINT; but to men, whose sole dependance for the support of themselves and families, and the consequent payment of their debts, and maintaining an honest reputation, is their daily labour and industry, it is far from presenting either an acceptable holiday, or source of fun, frolic, or freedom from con-straint. We cannot conceive the possibility of any philanthropic individual looking on unmoved and witnessing poor men trudging it to muster, distances of from half a mile to ten miles, or how any man of common sense can observe it and not pronounce it a positive calamity.

Our sentiments upon this subject are not new. We have more than once given expression to them-and feel some degree of satisfaction in the reflection that we contributed our mite towards procuring a melioration of the Militia requirements, in raising our voice against them, as they were, in common with others similarly situated as ourselves. But at the same time that a modification of them has taken place to a certain extent, we are not yet satisfied. Far from it. We complain of them-and that bitterly-as

they are.

It may so happen as that some particularly loyal and patriotic persons may feel disposed to question our sentiments upon these particular points. So let them. We tell them - and we trust we shall always be ready and willing to prove itthat we do not for a moment suspect ourselves upon the points in question; but at the same time that we trust if any emerg olicy should arise, we shall not be seeking a place in the rear rank, -we cannot for a moment reconcile the absurdiry of the existing Militia Law in its operations. The remedies which we would suggest are already before the public-are of several years' standing -- and We do not even now know how to amend

## SMALL POX.

Thro' this week the schooner Indian Queen, Captain Vigneau, from Quebec, arrived at Chatham, and so contrived it, as we are informed, as to land some of her passengers immediately on her arrival, at the same time she had the Small Pox on board. This vessel, altho' of the draught which compelled her to take a Pilot, came up without one, which upon enquiry is accounted for by the circumstance of her having been boarded at the entrance by a Pilot, and having compromised with him for half Pilotage. We entertain very little, if any, doubt, it was perfectly well understood between the parties acting, that there was contagious disease on board, and that the matter was done with the view of enabling the vessel to land her passengers stealthily. Immediately upon her arrival having been reported she was ordered to quarantine, which order she obeyed, but the next day her Captain made part and parcel of our community, mixing with us in the streets and places of business. A Special Session has been held, resulting from which fifteen persons, passengers and crew, were landed on Thursday at noon, and are now in the hospital in Chatham.

We would ask how are the Captain and Pilot to be dealt by in this case? Did the Pilot read or exhibit to the Captain the regulations of the Sessions respecting any vessels which he may board? And if not, why not? Was he actually on board? and if so why leave the vessel, knowing her to have infectious disease on board? Did the Captain know the regulations? and if yea, why disobey them? If nay, why not report the state in which his vessel was before he dared to land either his passengers or himself? Can he or will he dare to plead ignorance as to what his duty was in this respect? And if ignorant will he be suffered to plead that ignorance in justification? We have no doubt whatever upon our mind the whole matter was made up between the Captain and Pilot; and the lives of thousands jeopardized by their improper and illegal conduct; and do charitably hope that both the one and the other may be called to a proper account for such conduct, and compelled to pay the smart.

EUROPEAN NEWS .- About 7 o'clook on the evening of Sunday last, the steamer Caledonia arrived at Halifax, after a pleasant passage of 12 days. She had a large number of passengers on board. It is a singular fact that since the steamers have commenced running, the first August boats have all arrived on the 16th of the month. The Britannia got safe home on the 31st July. The mail for New Brunswick left Halifax about half past eight o'clock on Sunday evening, for St. John; our portion of it, of course, remained at Dorchester until the regular mail came up on Thursday.

We have obtained our regular files of papers, but do not perceive in them any intelligence of special importance. Another attempt has been made on the life of Louis Philippe-but it failed. He was sitting in the balcony of the Palace of the Tuileries, when a person in the crowd discharged two shots from a pistol at him. The ruffian was immediately arrested. This is the seventh attempt. It is stated that the Russian government is considerably alarmed at the apprehended total failure of the present harvest. The blight has made sad havoc among the potatoes in Ireland, and there are some complaints from England. The weather had been very variable in Britain, which had coused considerable uneasiness for the favorable termination of the harvest.

HALIFAX .- Her Majesty's war steamer Vesuvius arrived at the above-named port on the night of Friday week, from the Gulf of Mexico, with despatches for the Admiral. She had on board 39 cases of Yellow Fever, and had lost by this frightful distemper nine men and one midshipman. She immediately proceeded up the North West arm, and landed the sick on Melville Island.

There is a great scarcity of water in the city, and the inhabit ants suffered great inconvenience in consequence.

NEWFOUNDLAND .- Papers from this Island state that-"On the morning of the 17th July, about half-past four o'clock, one of the buildings forming the estabishment of Messrs. C. F. Bennett & Co. Isle of Valen, Placentia Bay, was discovered to be on fire in the middle floor, and before the fire was subdued, the store in which it originated and the adjoining one were burnt to the ground. In the one store were provisions to the value of £800 which were all destroyed, in the other stores were outfits for the fishery, and sails &c, for the vessels employed. By great exertions the shop and dry goods and hardware store was saved though only 18 feet from the burnt premises. There are strong suspicions of its having been the work of an incendiary, as the storekeeper had been in the store half an hour before the alarm was given and observed no appearance of fire."

The Home Government has granted £30,000 for the relief of the sufferers by the late fire.
