a rich reward to the husbandman. The intelligence from the other counties to the Northward, as well as from Novascotia and Canada, are equally favourable. The potatoes look remarkably strong and healthy. A less quantity than formerly has been put into the ground, but should they continue to thrive, and be not affected by blight or rot, there will be sufficient for next year's consumption. In conversing with farmers, we learn that more attention than formerly has been bestowed by them in selecting seed. A larger amount than usual of wheat and oats have been planted; particularly of the latter, a large portion of which has been sowed at a late period, with the intention of being reaped in a green state for fodder.

QUEBEC AND HALIFAX RAILWAY .-The St. John Colonial Advocate contains the following paragrahs on this imporlant subject.

"We have it from good authority that held-of funds in certain Saving's Banks in Engand have made a serious proposition to go-vernment in case the railroad project is pro-ceeded with, to build it with their own hands on condition that a certain moderate interest be guranteed them on its completion They will finish it also, so says the story in five years, if their offer be accepted. This is a curious fact, and proves what a vast amount of capital lies in England unemployed and seeking profitable investment, and how easy it would be for a wise government to make room for the profita-ble use of capital in a new country like this, full of all kinds of raw material if we may so call it, capable by labor to be made valuable. "We would rejoice to learn that this proposi-

"We would rejoice to learn that this proposi-tion of the British operatives is entertained, as it would bring into the Province the very kind of men we want—men who have begun to save and who feeling thas their independence, would continue to save and accumulate capital. We greatly want also a mixture of English and Scotch emigrants of the labouring classes, and by this means may get them. No effort should be spared to accomplish this very desi-rable object."

QUEBEC .- The papers deny the report which has been going the rounds of the Provincial press, that the Asiatic Cholera had made its appearance in that city.

NEWFOUNDLAND .- We copy below some further intelligence respecting the late disastrous fire at the above-named place, from papers received at Halifax by the steamer Unicorn.

The Royal Gazette has the following enu-meration of the public buildings and establish

ments destroyed : "S. John's Parish Church ; the beautiful new Convent of the Nuns of the Presentation Order; the Convent School House (not finish-Order; the Convent School House (not foish-ed); the Court House, Gaol, Sheriff's House and offices, Police Office, &c.; the Exchange Bailcings, including Commercial Room, In-surance Office, Office of Board of Control, Agricultural Society's Museum. &c.; the Post Office; Colonial Treasurer's Office; Savings' Bank; Bank of British North America; Cus-tom House; Ordnance Store and Queen's Wharf; Governors Wharf; Mechanics' Hal; the Brading Room and Library, and McMar-do's Library; the various Hotels; together with the offices of all the Newspapers publish-ed here-viz, the Royal Gazette, Public Led-ger, Newfoundlander, Times, Patriot, Morning Courier. We may here remark that within a Period of about 30. years the establishment of the official Gazette has been wholly or partialthe official Gazette has been wholly or partially consumed by fire no less than five times. In this instance its Press and nearly the whole of its materials were destroyed, principally after removal."

The same paper notices, -- " as a proof of the security afforded, in cases of fire, by pro-perly constructed safety vaults, we may men-

habited by about 3000 families, being in the suburbs of the city, whereas here the fire has been in the business part of the town, and the value of the property destroyed bears no-pro-portion. In Quebec about one fourth in value of all the buildings was burst; in S<sup>c</sup>. John's we would say nine-tenths, and the destruction of M-rchandize here was infinitely greater than there."

SHEDIAC .- A Correspondent informs us that such is the spirit of opposition now existing in the Packe: line between Shediac and Bedeque, P. E. Island, that the fare of passengers has been reduced to one third during the last fortnight, and is now as low as two shillings and six pence. A great many of the Beau monde are constantly availing themselves of this favourable opportunity of paying a visit to the Island. The accommodations are on a very superior scale, and the comfort, convenience and attention bestowed on passengers is highly creditable to the spirited proprietors.
