Halifax Register, April 7. Steam Communication-Halifax and Port-land.-It has been stated that Mr. A. W. Godfrey addressed a Public Meeting at Portland, on the subject of Steam Communication between that Port and Halifax, and the intermediate Ports of Yarmouth, Liverpool and Lunenburg, and that \$40,000 were subscribed towards the enterprize—a sum nearly twice that stated as requisite by Messrs Stairs & Rolton, in their prospectus. This looks well. The enterprize will be proceeded, with and must succeed. The following article on the aubject, we take from the New York Anglo-American—it will encourage the friends of the andertaking here:—

"The success which has recently attended the enterprise of running an express between these places over land to Annapolis, and thence by steamer across the Bay of Fundy, has attracted, we are happy to perceive, the no-tice of individuals in Halifax, to the advantage of steamboat communication with Port-land,—touching at Lunenburg, Liverpool, and Yarmouth, on both passages. This will be a most delightful route for parties of pleasure in summer, and connected as it will be by the Rail Road with Boston, must bring all these points into immediate contact with that city, and ultimately with New York.

Liverpool, Lunenburg, and Yarmouth, at which it is proposed to call,—and in the latter place one-third of the outfit has been subscribed the entire cost being only \$24,000,—are wealthy and flourishing towns, extensively engaged in the West India trade,—and importing largely from the United States. To men of business, therefore, the proposed under-taking is one of importance. The first two places are from eight to twelve hours sail from Halifax; Yarmouth lies 30 miles from Cape Sable, and about the distance from An-napolis Basin, whence a stage runs to Halifax two or three times a week. From Yarmouth to Portland the distance may be estimated at two hundred miles.

From Portland to Montreal the distance is

225 miles, and was traversed by the late express at the average rate of thirteen miles an hour, and in several instances travelling a mile in four minutes. Whether the contemplated railroad between these places shall be established or not, this will be a desirable route for men of business, although the northern and European travelling must concentrate at Baston, the necessary must concentrate at Baston, the necessary more in the trate at Boston; the passage money in the steamers to and from Liverpool from that be-ing the same as that from Halifax to England.

The steamer which it is intended to employ on the contemplated route, will be constructed of iron; we should presume it will be procured without delay for the sake of the summer travelling, and that a line will thus be established, which has hitherto been much neglected by the people of Halifax,—if viewed merely as connecting the capital of the Province with other parts of Nova Scotia; the deficiency having been supplied by the enterprise of Mr. Whitney, of St. John New Brunswick."

Washington, March 30 .- General Scott has sent in an estimate, among others, to the Mi-litary Committees of both houses requiring forty-five or fifty thousand men for fort and other frontier defences. One third of this force is to consist of regular troops, the other two thirds of volunteers—this, it must be remem-bered is all that he requires for defensive operations in case of a war with England; but for offensive movement, the regular troops would have to be increased according to the exigencies that may arise from time to time. The President and Cabinet have at last decided President and Cablet have at last declined upon the effective measures, provided Congress only second their efforts, for putting the country in a proper state of defence. If our difficulties with England be not settled amicably in less than three months, war will inevitably ensue between both countries.
