REWARD.—The Royal Gazette contains a Proclamation, issued by command of His Excellency, offering a Reward of One Hundred Pounds to such person as shall give information to Her Majesty's Attorney General, as may lead to the apprehension of the parties who murdered David Campbell, of the city of Saint John.

PROVINCIAL APPOINTMENTS.—Daniel Hanington, and Thomas E. Smith, Esqrs. have been appointed Commissioners for Steam Boats at the port of Shediac, under the Act of the Assembly.

CANADA.—We copy the following extract from a lengthy report issued by a Committee appointed by the inhabitants of Montreal, to look after the health of the city.

"During the six weeks ending the 24th July, there have died in Montreal, 596 residents—316 emigrants in town—and 1134 in the sheds. Total, 2046.

"Corresponding weeks last year. 318 residents—7 emigrants. Total, 325."

The Montreal Miner contains the following paragraphs:—

"Death has again visited the religious communities of Montreal since our last issue. We have to lament the decease of a respected minister of the Gospel: the Rev. Mr. Rey, one of the priests attached to the Bishop's establishments, died yesterday morning, aged about 60 years. At the Seminary, the Rev. Mr. Macmahon is dying, all hopes of his recovery has been given up; the other gentlemen whose illness we have announced are not quite out of danger.

"Eight of the Grey Nuns are still in the sick ward, sister Pomerville is at the last extremity; sisters Reed and Denis are in danger.

"Three ladies of the Hotel-Dieu Nunnery are seriously ill; they are sister Portelance (in danger) and sisters Doirier and Marchesseau.

"At the Asyle de la Providence, 17 of the Nuns are sick; five are dangerously so, and particularly sister Michon. Eight servant girls attached to the establishment, and who have been tending the sick, have caught the disease and are bed-ridden."

The Board of Health at Quebec on the 2nd came to the following resolution:

Resolved—That the present Burying Grounds near the Marine Hospital being now full of bodies, emitting a most noisome effluvia, highly dangerous to the health of the citizens, no further burials do take place there, and that those whose duty it is, do take immediate steps to provide another for that purpose.

A Correspondent at Montreal, under date of the 4th August, writes to the Editor of the Quebec Gazette as follows:

"The number of deaths at the Sheds since the 30th ult. is 136—a number of cases of fever have occurred in town."

The Quebec Mercury of the 2nd inst., contains the following remarks respecting the state of affairs at Grosse Isle:—

"The last accounts from Grosse-Isle are of a most harrowing character, and forebode gloomily. We have received late information from the Quarantine Station, which states the late arrivals to present an equal condition of equal misery, mortality and disease, to that which existed on board the Virginias, &c. The barque Lady Campbell, from Dublin, had lost thirteen, and had 59 sick on her arrival. The barque Naomi, from Liverpool, with 334 passengers, lost 78, and had upwards of 109 sick on her arrival at Grosse Isle. The master of the Virginias was dying or dead when the steamer left the island last evening, and there remained but three hands of the ship's company fit for duty. The mate is dead, and the balance are said to be ghastly, yellow looking spectres, of whom not more than six or eight are able to exert themselves, they are all long bearded and hollow-cheeked. The Yorkshire, from Dublin, and Sir Henry Poynter, from Cork, are pretty much in the same state.

As regards Grosse Isle, to begin with, our prospect is a sad one. If these passengers are landed, under the description of healthy,—having undergone all the previous exposure to the miasma of crowded vessels, thronged with disease, and reeking of filth, and immediately receive a nourishing diet, and with it are subjected to the atmospheric changes to which a

residence in tents will expose them (at this changing season of the year)—how many, we ask, are likely to reach the termination of their voyage.

The number of sick at Grosse Isle is receiving a daily augmentation, not only from the fresh cases landed from newly arrived vessels, but from the quasi healthy undergoing quarantine, on shore, who gradually add to the roster of the hospital. The cold season is at hand. The sheds and tents are becoming objectionable and fatal. They cannot be made comfortable; they cannot be heated. The only hospital in Quebec is full, or more than full. What is to be done? Six weeks hence what will be done with the thousands of sick at Grosse Isle.

In Quebec nothing has been done towards providing for our citizens. We have heard to day of the death of one poor soul in a hangar, who died there, having been turned out of the house in which he took sick, because he could not be received into the Marine Hospital! We have other cases of a similar nature before us.

Both the Government and the City of Quebec must move. Quebec will be the depot of these invalids, for they cannot be kept at Grosse Isle in the winter."

To CORRESPONDENTS.—We have unfortunately mislaid our Douglasfield correspondent's letter, complaining of the depredations committed by cattle, horses, and hogs going at large in that settlement. Another Correspondent writes to us, complaining of the oft-repeated grievance of pigs being allowed to range at large through the town and parish of Chatham, where they are constantly committing depredations in gardens, &c.

We sincerely trust that this subject will occupy the attention of the Grand Jury at the approaching Session of the Supreme Court; and should nothing effectual be then done, to stop this sad nuisance, we shall advise our neighbours to deal summarily with the creatures they find trespassing, and let the parties, who persist in keeping them, to the injury and annoyance of their neighbors, seek redress where they can obtain it. The inhabitants of the town have borne too long and too patiently the nuisance spoken of.

It is useless to find fault with the Hog-Reeves: when they endeavour to do their duty they are assailed and vilified; and as to taking a pig to pound, it is a farce—for he is no sooner there than he is released. The following is an extract from our correspondent's letter.

"Observing in the last Gleaner, you intend to insert something respecting the hogs in the Douglasfield settlement next week, I wish while you are on the subject, not to forget the Gentlemen Hog-reeves of the town. You can't not lay on them too heavily. The town is infested with the long snout gentry, from end to end, and yet no one is taken. About three weeks ago, four of these functionaries came up through the streets with ropes, ready to hang them all—they caught three or four, and were carrying them away triumphantly, when the good natured folk gave them back to their owner. Need I tell you, that their backs were scarcely turned, when they were again let loose on the public, and have been so ever since; from John Hea's gate, to Mal. Dwyre's you can see half a dozen pigs any time in the day, and I presume other parts of the town are similarly infested. You are tired—I am tired—and so is every body tired of speaking about hogs—and what is to be done, when persons who are sworn to look after them, will not do their duty."

COUNTY KENT.—Supreme Court.—At the Court of Oyer and Terminer, held for this County on the 3rd inst. William Chesswell, was tried and found Guilty of a capital offence upon a Female under the age of 10 years. The prosecution was conducted by the Hon. J. W. Weldon, Queen's Counsel, and the Prisoner defended by John M. Johnson, Jun. and James A. James, Esqrs. His Hon. Judge Street, passed sentence of death upon the prisoner, and named the 2nd November next as the day for his execution.

John H. Clair was also tried on a charge of Forgery; the same gentlemen conducted the prosecution and defence as in the above case.—The Jury found him Not Guilty.

Philip Markey, and Edward Markey, were also tried and found Guilty for assaulting the Sheriff in the discharge of his duty, and sentenced to two months imprisonment in the County Gaol. They

were most ably defended by A. R. Wetmore, Esquire, from St. John.

DAGUERRETYPE LIKENESSES.—Mr. A. B. Vining, Artist, has been occupied for some time past, in the Hall of the Mechanics' Institute, in Chatham, in the business of his profession.
